HOUSE BILL NO. 1660

1 AN ACT TO AUTHORIZE THE BOARD OF SUPERVISORS OF FORREST  
2 COUNTY TO CONTRIBUTE FUNDS TO ASSOCIATION FOR RETARDED CITIZENS,  
3 BIG BROTHERS/BIG SISTERS OF SOUTHEAST MISSISSIPPI, BOY SCOUTS OF  
4 AMERICA, GULF PINE GIRL SCOUT COUNCIL, HATTIESBURG DOWNTOWN  
5 ASSOCIATION, INC., HATTIESBURG LITTLE LEAGUE BASEBALL ASSOCIATION,  
6 NEIGHBORHOOD EDUCATION ENHANCEMENT DEVELOPMENT SERVICES, SALVATION  
7 ARMY, SALVATION ARMY BOYS AND GIRLS CLUB, PEARL RIVER VALLEY  
8 OPPORTUNITY AND PINEBELT ASSOCIATION FOR COMMUNITY ENHANCEMENT;  
9 AND FOR RELATED PURPOSES.

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

11 **SECTION 1.** The Board of Supervisors of Forrest County,  
12 Mississippi, in its discretion, may provide and expend county  
13 funds from any available funds of the county, in an amount not to  
14 exceed Sixty-two Thousand Dollars (\$62,000.00) during fiscal year  
15 2006, for the purpose of providing funds necessary for the  
16 continuation of service programs provided by the Association for  
17 Retarded Citizens, Big Brothers/Big Sisters of Southeast  
18 Mississippi, Boy Scouts of America, Gulf Pine Girl Scout Council,  
19 Hattiesburg Downtown Association, Inc., Hattiesburg Little League  
20 Baseball Association, Neighborhood Education Enhancement  
21 Development Services (N.E.E.D.S.), Salvation Army, Salvation Army  
22 Boys and Girls Club, Pearl River Valley Opportunity and Pinebelt  
23 Association for Community Enhancement (P.A.C.E.).

24 During fiscal year 2006, funds to the organizations shall not  
25 exceed the amounts as follows:

37       **SECTION 2.** This act shall take effect and be in force from
