HOUSE CONCURRENT RESOLUTION NO. 65

1 A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING MR.
2 RICHARD WILSON UPON HIS RECEIVING THE MISSISSIPPI CIVIL
3 DEFENSE-EMERGENCY MANAGEMENT ASSOCIATIONS BOARD OF DIRECTORS
4 AWARD.

5 WHEREAS, Mr. Richard Wilson was awarded the Mississippi Civil
6 Defense-Emergency Management Associations (MCDEMA) Board of
7 Directors Award for his outstanding service as the Emergency
8 Management Director for Rankin County; and

9 WHEREAS, as the first recipient of the MCDEMA Board of
10 Directors Award, Mr. Wilson was chosen for this distinguished
11 honor due to his superb service as Emergency Management Director
12 for Rankin County for 10 years; and

13 WHEREAS, Mr. Wilson is known throughout the state as a highly
14 organized individual who ensures that Rankin County has the
15 resources and needed manpower to help individuals in emergencies
16 when the need arises; and

17 WHEREAS, as the Emergency Management Director of Rankin
18 County, Mr. Wilson's duties and responsibilities cover a variety
19 of areas such as: coordinating rescue cleanup in areas hit by
20 tornados or in areas affected by solid hazardous materials;
21 heading the county's Homeland Security efforts; overseeing the
22 county's 34-siren severe warning system and overseeing the
23 county's 715-radio communication system; and

24 WHEREAS, Mr. Wilson also oversees Rankin County's
25 911-Addressing System and Fire Coordinator's Office, as well as
26 the manufacture of street signs for Rankin County streets and
27 roads; and

28 WHEREAS, in addition to being a diligent and effective
29 Emergency Management Director, which entails a multitude of duties
30 and responsibilities, Mr. Wilson also is an active member of his
31 community and serves many civic organizations and youth programs,
32 and he is the loving husband of the former Ann Berry Wilson and
33 the doting father of their two children, Margo and Tanner; and

34 WHEREAS, it is the policy of this Legislature to recognize a
35 dedicated employee such as Mr. Richard Wilson, who has gone well
36 beyond the call of duty to help ensure that Rankin County and
37 surrounding areas receive timely, well-organized and efficient
38 help during emergencies:

40 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING
41 THEREIN, That we do hereby commend and congratulate Mr. Richard

44 outstanding career achievements as Emergency Management Director
45 of Rankin County.
