HOUSE CONCURRENT RESOLUTION NO. 67

1 A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING MRS.  
2 MARIE PASLAY FOR BEING SELECTED AS INSTRUCTOR OF THE YEAR AT THE  
3 PERKINSTON CAMPUS OF THE MISSISSIPPI GULF COAST COMMUNITY COLLEGE.

4 WHEREAS, Mrs. Marie Paslay, a resident of Lumberton,  
5 Mississippi, has been selected as Instructor of the Year at the  
6 Perkinston Campus of the Mississippi Gulf Coast Community College  
7 in recognition of her distinguished service to the college; and

9 of the Mississippi Gulf Coast Community College to honor  
10 instructors, such as Mrs. Paslay, who are chosen from nominations

15 instructor, has been employed at Mississippi Gulf Coast Community  
16 College as an instructor for the past 18 years; and

17 WHEREAS, a staunch believer in education, Mrs. Paslay  
18 received her bachelor and master of science degrees from the  
19 University of Southern Mississippi; and

20 WHEREAS, Mrs. Paslay, an active member of the community,  
21 holds membership in the Stone-Wiggins Soccer Association and has  
22 served as a mentor to students in public education; and

23 WHEREAS, Mrs. Paslay is a member of the Mississippi Gulf  
24 Coast Community College Alumni Association and Foundation and  
25 serves as a member of the Alabama-Mississippi Sociological  
26 Association; and

27           WHEREAS, in addition to being selected as Instructor of the  
28 Year, Mrs. Paslay was also the Mississippi Humanities Council  
29 Instructor of the Year in 2003; and

30           WHEREAS, Mrs. Paslay is an active member of First United  
31 Methodist Church of Wiggins, Mississippi, and serves as Acolyte  
32 Coordinator and member of the Administrative Council; and

33           WHEREAS, it is the policy of this Legislature to recognize  
34 and commend exemplary and outstanding instructors such as Mrs.  
35 Marie Paslay, who has dedicated her career to teaching and  
36 positively molding the minds of young people of this state:

38 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING
