HOUSE CONCURRENT RESOLUTION NO. 114
(As Adopted by the House)

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE
2 PURPOSE OF THE FURTHER CONSIDERATION AND PASSAGE OF CERTAIN BILLS
3 THAT DIED IN CONFERENCE.

4 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
5 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the Joint
6 Rules of the House and the Senate, including all the deadlines and
7 other provisions imposed by Joint Rule No. 40, are suspended for
8 the purpose of permitting the further consideration and passage of
9 the following bills that died in conference:

10 HOUSE BILL NO. 744:

11 AN ACT TO AMEND SECTION 27-7-22.23, MISSISSIPPI CODE OF 1972,
12 WHICH PROVIDES FOR AN INCOME TAX CREDIT FOR PORT FACILITIES AT
13 STATE, COUNTY AND MUNICIPAL PORTS FOR IMPORT OF CARGO, TO ADD A
14 DATE OF REPEAL ON THAT SECTION; TO AMEND SECTION 27-7-22.24,
15 MISSISSIPPI CODE OF 1972, WHICH REQUIRES THE MISSISSIPPI
16 DEVELOPMENT AUTHORITY TO MAKE ANNUAL INCOME TAX CREDIT IMPACT
17 REPORTS, TO ADD A DATE OF REPEAL ON THAT SECTION; TO REPEAL
18 SECTION 3, CHAPTER 530, LAWS OF 2004, WHICH PROVIDES FOR THE
19 REPEAL OF THOSE SECTIONS; AND FOR RELATED PURPOSES.

20 HOUSE BILL NO. 1492:

21 AN ACT TO AUTHORIZE THE ISSUANCE OF STATE GENERAL OBLIGATION
22 BONDS IN THE AMOUNT OF \$4,000,000.00 TO PROVIDE FUNDS TO ASSIST
23 WAYNE COUNTY, CLARKE COUNTY, LAUDERDALE COUNTY, TISHOMINGO COUNTY,
24 ALCORN COUNTY, UNION COUNTY, LAFAYETTE COUNTY AND TIPPAN COUNTY,
25 AND MUNICIPALITIES LOCATED WITHIN SUCH COUNTIES, IN PAYING COSTS
26 ASSOCIATED WITH CONSTRUCTION AND IMPROVEMENT OF RAILROAD LINES AND
27 RELATED FACILITIES LOCATED IN SUCH COUNTIES AND WHICH CONSTITUTE

28 PART OF A COOPERATIVE PLAN OF SUCH COUNTIES FOR THE IMPROVEMENT OF
29 RAIL TRANSPORTATION; AND FOR RELATED PURPOSES.

30 HOUSE BILL NO. 1495:

31 AN ACT TO AUTHORIZE THE ISSUANCE OF GENERAL OBLIGATION BONDS
32 OF THE STATE OF MISSISSIPPI FOR THE PURPOSE OF PROVIDING FUNDS FOR
33 REPAIR, RENOVATION, FURNISHING AND EQUIPPING OF THE OLD CAPITOL
34 AND TENANT BUILD-OUT EXPENSES RELATED TO REPAIR AND RENOVATION OF
35 THE OLD CAPITOL; TO AMEND SECTIONS 1 THROUGH 16, CHAPTER 543, LAWS
36 OF 2002, TO EXTEND THE PERIOD WITHIN WHICH BONDS AUTHORIZED UNDER
37 SUCH LAW FOR THE MISSISSIPPI COMMUNITY HERITAGE PRESERVATION GRANT
38 FUND MAY BE ISSUED; AND FOR RELATED PURPOSES.

39 HOUSE BILL NO. 1634:

40 AN ACT TO AUTHORIZE THE ISSUANCE OF STATE GENERAL OBLIGATION
41 BONDS FOR THE PURPOSE OF MAKING CAPITAL IMPROVEMENTS FOR
42 INSTITUTIONS OF HIGHER LEARNING, STATE AGENCIES AND COMMUNITY AND
43 JUNIOR COLLEGES; TO AUTHORIZE THE ISSUANCE OF STATE GENERAL
44 OBLIGATION BONDS FOR THE PURPOSE OF PROVIDING FUNDS FOR THE
45 SOUTHERN ARTS AND ENTERTAINMENT CENTER; TO AUTHORIZE THE ISSUANCE
46 OF STATE GENERAL OBLIGATION BONDS TO PROVIDE FUNDS FOR CAPITAL
47 IMPROVEMENTS AT AN ECONOMIC DEVELOPMENT AND TOURISM DESTINATION
48 FACILITY IN HANCOCK COUNTY, MISSISSIPPI, THAT FEATURES A SPACE,
49 SCIENCE AND EDUCATION CENTER; TO REQUIRE THE COMMITMENT OF A
50 CERTAIN AMOUNT OF PRIVATE, LOCAL OR FEDERAL FUNDS FOR SUCH PROJECT
51 AS A CONDITION PRECEDENT TO THE ISSUANCE OF SUCH BONDS; TO AMEND
52 SECTION 57-75-5, MISSISSIPPI CODE OF 1972, TO REVISE THE
53 DEFINITION OF THE TERM "PROJECT" UNDER THE MISSISSIPPI MAJOR
54 ECONOMIC IMPACT ACT; TO AMEND SECTION 57-75-15, MISSISSIPPI CODE
55 OF 1972, TO AUTHORIZE THE ISSUANCE OF BONDS FOR CERTAIN PROJECTS
56 UNDER THE MISSISSIPPI MAJOR ECONOMIC IMPACT ACT; TO AMEND SECTIONS
57 3 THROUGH 18, CHAPTER 541, LAWS OF 2001, AS LAST AMENDED BY
58 CHAPTER 1, LAWS OF 2004 THIRD EXTRAORDINARY SESSION, TO INCREASE
59 THE AMOUNT OF STATE GENERAL OBLIGATION BONDS THAT MAY BE ISSUED
60 FOR THE PURPOSE OF PROVIDING FUNDS FOR THE BUILDING FUND FOR THE

61 ARTS; TO AMEND SECTION 39-11-13, MISSISSIPPI CODE OF 1972, IN
62 CONFORMITY THERETO; TO AMEND SECTIONS 210 THROUGH 226, CHAPTER 1,
63 LAWS OF 2004 THIRD EXTRAORDINARY SESSION, AS AMENDED BY CHAPTER
64 458, LAWS OF 2005, TO INCREASE THE AMOUNT OF GENERAL OBLIGATION
65 BONDS AUTHORIZED TO BE ISSUED FOR THE MISSISSIPPI MUSEUM OF ART
66 FUND; TO AUTHORIZE THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE
67 STATE OF MISSISSIPPI FOR THE PURPOSE OF PROVIDING FUNDS FOR THE
68 REPAIR, RENOVATION, FURNISHING AND EQUIPPING OF A BUILDING AND
69 FACILITIES FOR A NEW STATE RECORDS CENTER AT THE OLD FARMERS'
70 MARKET LOCATION IN JACKSON, MISSISSIPPI, AND EXPENSES RELATED TO
71 MOVING RECORDS TO THE NEW CENTER; AND FOR RELATED PURPOSES.

72 HOUSE BILL NO. 1638:

73 AN ACT TO AUTHORIZE THE ISSUANCE OF \$50,000,000.00 IN STATE
74 GENERAL OBLIGATION BONDS TO PROVIDE FUNDS FOR THE DESIGN OF,
75 PURCHASE OF EQUIPMENT FOR, AND CONSTRUCTION OF A STATEWIDE
76 WIRELESS COMMUNICATION SYSTEM; TO PROVIDE THAT THE BOND PROCEEDS
77 SHALL BE DEPOSITED INTO THE INTEGRATED PUBLIC SAFETY
78 COMMUNICATIONS FUND; TO AUTHORIZE THE ISSUANCE OF \$10,000,000.00
79 IN STATE GENERAL OBLIGATION BONDS TO PROVIDE FUNDS FOR THE
80 CONSTRUCTION OF A COOPERATIVE DATA CENTER FOR THE MISSISSIPPI
81 DEPARTMENT OF INFORMATION TECHNOLOGY SERVICES; AND FOR RELATED
82 PURPOSES.

83 SENATE BILL NO. 3080:

84 AN ACT TO AMEND SECTIONS 3 THROUGH 18, CHAPTER 541, LAWS OF
85 2001, AS AMENDED, TO INCREASE THE AMOUNT OF STATE GENERAL
86 OBLIGATION BONDS THAT MAY BE ISSUED FOR THE PURPOSE OF PROVIDING
87 FUNDS FOR THE BUILDING FUND FOR THE ARTS; TO AMEND SECTION
88 39-11-13, MISSISSIPPI CODE OF 1972, IN CONFORMITY THERETO; TO
89 AMEND SECTIONS 210 THROUGH 226, CHAPTER 1, LAWS OF THE THIRD
90 EXTRAORDINARY SESSION OF 2004, AS AMENDED, TO INCREASE THE AMOUNT
91 OF GENERAL OBLIGATION BONDS AUTHORIZED TO BE ISSUED FOR THE
92 MISSISSIPPI MUSEUM OF ART FUND; AND FOR RELATED PURPOSES.

93 SENATE BILL NO. 3086:

94 AN ACT TO AUTHORIZE THE ISSUANCE OF \$20,000,000.00 IN STATE
95 GENERAL OBLIGATION BONDS TO PROVIDE FUNDS FOR THE LOCAL SYSTEM
96 BRIDGE REPLACEMENT AND REHABILITATION FUND; TO AMEND SECTION
97 65-37-13, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT THE
98 LEGISLATURE SHALL NOT BE REQUIRED TO APPROPRIATE FUNDS DURING THE
99 2006 REGULAR SESSION FOR DEPOSIT INTO THE LOCAL SYSTEM BRIDGE
100 REPLACEMENT AND REHABILITATION FUND; AND FOR RELATED PURPOSES.

101 SENATE BILL NO. 2922:

102 AN ACT TO AMEND SECTION 41-41-33, MISSISSIPPI CODE OF 1972,
103 TO REQUIRE THAT A WOMAN BE GIVEN THE OPPORTUNITY TO VIEW A
104 SONOGRAM OR LISTEN TO THE HEARTBEAT OF HER UNBORN CHILD BEFORE
105 CONSENTING TO AN ABORTION; TO AMEND SECTION 41-41-39, MISSISSIPPI
106 CODE OF 1972, TO CLARIFY CRIMINAL PENALTIES FOR VIOLATIONS OF THIS
107 ACT; AND FOR RELATED PURPOSES.
