HOUSE CONCURRENT RESOLUTION NO. 121

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE
2 PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION,
3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO AMEND
4 SECTIONS 1 THROUGH 12 OF CHAPTER 1012, LOCAL AND PRIVATE LAWS OF
5 2004, TO REVISE THE DEFINITION OF THE TERM "HOTEL" OR "MOTEL"
6 UNDER THE LAW THAT AUTHORIZES THE BOARD OF SUPERVISORS OF HARRISON
7 COUNTY TO IMPOSE A SPECIAL TAX ON THE GROSS PROCEEDS OF ROOM
8 RENTALS OF HOTELS OR MOTELS; TO REQUIRE PERSONS, FIRMS OR
9 CORPORATIONS ENGAGED IN THE BUSINESS OF OPERATING A HOTEL OR MOTEL
10 TO APPLY FOR AND OBTAIN A TAX IDENTIFICATION NUMBER FROM THE STATE
11 TAX COMMISSION; TO AMEND CHAPTER 58, LAWS OF EXTRAORDINARY SESSION
12 OF 1954, AS LAST AMENDED BY CHAPTER 1012, LOCAL AND PRIVATE LAWS
13 OF 2004, IN CONFORMITY THERETO; AND FOR RELATED PURPOSES."

14 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
15 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the Joint
16 Rules of the House and the Senate, including all the deadlines and
17 other provisions imposed by Joint Rule No. 40, are suspended for
18 the purpose of requesting the drafting, and the introduction,
19 consideration and passage, of a bill entitled "AN ACT TO AMEND
20 SECTIONS 1 THROUGH 12 OF CHAPTER 1012, LOCAL AND PRIVATE LAWS OF
21 2004, TO REVISE THE DEFINITION OF THE TERM "HOTEL" OR "MOTEL"
22 UNDER THE LAW THAT AUTHORIZES THE BOARD OF SUPERVISORS OF HARRISON
23 COUNTY TO IMPOSE A SPECIAL TAX ON THE GROSS PROCEEDS OF ROOM
24 RENTALS OF HOTELS OR MOTELS; TO REQUIRE PERSONS, FIRMS OR
25 CORPORATIONS ENGAGED IN THE BUSINESS OF OPERATING A HOTEL OR MOTEL
