- 2 MATHEWS TO THE MISSISSIPPI STATE MEDICAL ASSOCIATION (MSMA) AND
- 3 EXPRESSING DEEPEST SYMPATHY TO HIS FAMILY AND FRIENDS UPON HIS
- 4 PASSING.
- 5 WHEREAS, Mr. Charles L. Mathews was employed by the
- 6 Mississippi State Medical Association (MSMA) for a total of 35
- 7 years, where he served 26 years as the association's executive
- 8 director before his retirement in 1998, departed this earthly life
- 9 on March 2, 2006, causing great sorrow and loss to his family and
- 10 friends; and
- 11 WHEREAS, a native Mississippian who was reared in Maryland,
- 12 graduated from Louisiana State University, and undertook
- 13 additional graduate studies in law and management at LSU, Syracuse
- 14 University and Jackson School of Law, and honorably served his
- 15 country from 1952-1955 with the United States Army; and
- WHEREAS, Mr. Mathews joined the MSMA staff in 1960 and served
- 17 as the association's first full-time lobbyist until 1969, when he
- 18 left the association to join the staff of Governor John Bell
- 19 Williams; and
- 20 WHEREAS, while serving on Governor Williams' staff, Mr.
- 21 Mathews was instrumental in both drafting and securing legislative
- 22 passage in 1969 of the law establishing Mississippi's Medicaid
- 23 program, and was subsequently named deputy director of the state
- 24 agency responsible for designing, organizing and implementing the
- 25 Title XIX program throughout Mississippi; and
- 26 WHEREAS, Governor Williams sought the assistance of Mr.
- 27 Mathews and appointed him Commissioner of Mississippi's State

28 Department of Welfare in 1971, where he led the agency for the
```

- 29 remainder of Governor Williams' term; and
- 30 WHEREAS, Mr. Mathews returned to the MSMA in 1972 as its
- 31 executive director serving in that capacity until his retirement
- 32 in 1998, where he established a vision that led to numerous
- 33 innovative programs that serves Mississippi physicians and their
- 34 patients, including the Mississippi Foundation for Medical Care;
- 35 and
- 36 WHEREAS, Mr. Mathews oversaw the 1985 conversion of MSMA to
- 37 "unified" membership status with the American Medical Association
- 38 and, at a time when other state medical societies were unable to
- 39 accomplish this feat, increasing MSMA membership approximately 53
- 40 percent; and
- 41 WHEREAS, the MSMA initiative to raise \$1.5 million to
- 42 capitalize the Physicians Care Insurance Company, a fully licensed
- 43 health care insurance company currently offering stock to members
- 44 of the association, was spearheaded by Mr. Mathews to better
- 45 utilize resources and establish a physician presence in the
- 46 financing of healthcare; and
- WHEREAS, Mr. Mathews' participation in the development of
- 48 organized medicine by the counsel he has provided the MSMA
- 49 delegation to the American Medical Association House of Delegates,
- 50 his work with the American Association of Medical Society
- 51 Executives, his effective guidance and oversight of advocacy work
- 52 in Mississippi's legislative and regulatory arenas; and
- WHEREAS, it is the policy of the House of Representatives to
- 54 commend the excellence and the diligence in the life of such a
- 55 dedicated individual as Mr. Mathews:
- NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
- 57 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, That we do hereby
- 58 commend the life and service of Mr. Charles L. Mathews for his
- 59 service to the Mississippi State Medical Association and express
- 60 deepest sympathy to his family and friends upon his passing.
