4	WHEREAS, during the past quarter century, under the Total
5	Force concept, the members of the National Guard and Reserve have
6	played an increasingly important role in protecting the national
7	security of the United States having to leave their places of
8	employment in the furtherance of freedom; and
9	WHEREAS, members of the National Guard and Reserve, including
10	the Army National Guard, Air National Guard, Army Reserve, Marine
11	Corps Reserve and Coast Guard Reserve, engage in rigorous
12	training, utilizing the most modern weapons systems, so as to be
13	able to augment active duty forces in defending the United States
14	of America in times of national emergency; and
15	WHEREAS, members of the National Guard and Reserve, both in
16	volunteer and in a mobilized status, have been called to active
17	duty to help protect the nation from further terrorist attacks;

19	WHEREAS, in order to carry out their military duties in an
20	effective fashion, members of the National Guard and Reserve
21	require the support and understanding of their civilian employers
22	and must know that their civilian jobs will still be available
23	when their military duty obligations have been completed; and
24	WHEREAS, Congress has passed the Uniform Services Employment
25	and Reemployment Rights Act to protect the civilian employment
26	rights of National Guard and Reserve personnel; and
