## SENATE BILL NO. 2122

AN ACT TO AMEND SECTION 41-3-15, MISSISSIPPI CODE OF 1972, TO 1 2 AUTHORIZE THE STATE BOARD OF HEALTH TO LEVY AN ADMINISTRATIVE FINE 3 ON RESTAURANT ESTABLISHMENTS OPERATING WITHOUT A PERMIT; AND FOR 4 RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. Section 41-3-15, Mississippi Code of 1972, is 6 7 amended as follows: 8 41-3-15. (1) There shall be a State Department of Health 9 which shall be organized into such bureaus and divisions as are 10 considered necessary by the executive officer, and shall be assigned appropriate functions as are required of the State Board 11 12 of Health by law, subject to the approval of the board.

13 (2) The State Board of Health shall have the authority to 14 establish an Office of Rural Health within the department. The 15 duties and responsibilities of this office shall include the 16 following:

17 (a) To collect and evaluate data on rural health18 conditions and needs;

19 (b) To engage in policy analysis, policy development
20 and economic impact studies with regard to rural health issues;

(c) To develop and implement plans and provide
technical assistance to enable community health systems to respond
to various changes in their circumstances;

(d) To plan and assist in professional recruitment and
 retention of medical professionals and assistants; and

26 (e) To establish information clearinghouses to improve27 access to and sharing of rural health care information.

of the health interests of the people of the state and to exercise
the rights, powers and duties of those acts which it is authorized
by law to enforce.

(4) The State Board of Health shall have authority:

33 (a) To make investigations and inquiries with respect 34 to the causes of disease and death, and to investigate the effect 35 of environment, including conditions of employment and other 36 conditions which may affect health, and to make such other 37 investigations as it may deem necessary for the preservation and 38 improvement of health.

39 (b) To make such sanitary investigations as it may, 40 from time to time, deem necessary for the protection and 41 improvement of health and to investigate nuisance questions which 42 affect the security of life and health within the state.

43 (c) To direct and control sanitary and quarantine
44 measures for dealing with all diseases within the state possible
45 to suppress same and prevent their spread.

(d) To obtain, collect and preserve such information
relative to mortality, morbidity, disease and health as may be
useful in the discharge of its duties or may contribute to the
prevention of disease or the promotion of health in this state.

50 (e) To enter into contracts or agreements with any
51 other state or federal agency, or with any private person,
52 organization or group capable of contracting, if it finds such
53 action to be in the public interest.

(f) To charge and collect reasonable fees for health services, including immunizations, inspections and related activities, and the board shall charge fees for such services; provided, however, if it is determined that a person receiving services is unable to pay the total fee, the board shall collect any amount such person is able to pay.

(g) To accept gifts, trusts, bequests, grants,

61 endowments or transfers of property of any kind.

62 (h) To receive monies coming to it by way of fees for63 services or by appropriations.

(i) (i) To establish standards for, issue permits and
exercise control over, any cafes, restaurants, food or drink
stands, sandwich manufacturing establishments, and all other
establishments, other than churches, church-related and private
schools, and other nonprofit or charitable organizations, where
food or drink is regularly prepared, handled and served for pay;
and

71 (ii) To require that a permit be obtained from the 72 Department of Health before such persons begin operation. If any 73 such person fails to obtain the permit required herein, the State Board of Health, after due notice and opportunity for a hearing, 74 may impose a monetary penalty not to exceed One Thousand Dollars 75 (\$1,000.00) for each violation. Money collected by the board 76 77 under this subparagraph (ii) shall be deposited to the credit of the State General Fund of the State Treasury. 78

(j) To promulgate rules and regulations and exercise control over the production and sale of milk pursuant to the provisions of Sections 75-31-41 through 75-31-49.

(k) On presentation of proper authority, to enter into and inspect any public place or building where the State Health Officer or his representative deems it necessary and proper to enter for the discovery and suppression of disease and for the enforcement of any health or sanitary laws and regulations in the state.

88 (1) To conduct investigations, inquiries and hearings, 89 and to issue subpoenas for the attendance of witnesses and the 90 production of books and records at any hearing when authorized and 91 required by statute to be conducted by the State Health Officer or 92 the State Board of Health.

93 To employ, subject to the regulations of the State (m) 94 Personnel Board, qualified professional personnel in the subject matter or fields of each bureau, and such other technical and 95 96 clerical staff as may be required for the operation of the 97 department. The executive officer shall be the appointing 98 authority for the department, and shall have the power to delegate the authority to appoint or dismiss employees to appropriate 99 subordinates, subject to the rules and regulations of the State 100 101 Personnel Board.

(n) To promulgate rules and regulations, and to collect data and information, on (i) the delivery of services through the practice of telemedicine; and (ii) the use of electronic records for the delivery of telemedicine services.

106 (o) To enforce and regulate domestic and imported fish107 as authorized under Section 69-7-601 et seq.

(5) (a) The State Board of Health shall have the authority, in its discretion, to establish programs to promote the public health, to be administered by the State Department of Health. Specifically, such programs may include, but shall not be limited to, programs in the following areas:

Maternal and child health; 113 (i) 114 (ii) Family planning; (iii) Pediatric services; 115 116 (iv) Services to crippled and disabled children; 117 (v) Control of communicable and noncommunicable disease; 118 (vi) Child care licensure; 119 120 (vii) Radiological health; 121 (viii) Dental health; 122 (ix) Milk sanitation; (x) Occupational safety and health; 123 124 (xi) Food, vector control and general sanitation; 125 (xii) Protection of drinking water; \*SS02/R316\* S. 126 (xiii) Sanitation in food handling establishments 127 open to the public;

128 (xiv) Registration of births and deaths and other 129 vital events;

130 (xv) Such public health programs and services as
131 may be assigned to the State Board of Health by the Legislature or
132 by executive order; and

133 (xvi) Regulation of domestic and imported fish for134 human consumption.

The State Board of Health and State Department of 135 (b) 136 Health shall not be authorized to sell, transfer, alienate or otherwise dispose of any of the home health agencies owned and 137 138 operated by the department on January 1, 1995, and shall not be authorized to sell, transfer, assign, alienate or otherwise 139 dispose of the license of any of those home health agencies, 140 141 except upon the specific authorization of the Legislature by an 142 amendment to this section. However, this paragraph (b) shall not 143 prevent the board or the department from closing or terminating the operation of any home health agency owned and operated by the 144 145 department, or closing or terminating any office, branch office or clinic of any such home health agency, or otherwise discontinuing 146 147 the providing of home health services through any such home health agency, office, branch office or clinic, if the board first 148 demonstrates that there are other providers of home health 149 150 services in the area being served by the department's home health agency, office, branch office or clinic that will be able to 151 152 provide adequate home health services to the residents of the area 153 if the department's home health agency, office, branch office or 154 clinic is closed or otherwise discontinues the providing of home 155 health services. This demonstration by the board that there are 156 other providers of adequate home health services in the area shall 157 be spread at length upon the minutes of the board at a regular or 158 special meeting of the board at least thirty (30) days before a \*SS02/R316\* S. 159 home health agency, office, branch office or clinic is proposed to 160 be closed or otherwise discontinue the providing of home health 161 services.

(c) The State Department of Health may undertake such technical programs and activities as may be required for the support and operation of such programs, including maintaining physical, chemical, bacteriological and radiological laboratories, and may make such diagnostic tests for diseases and tests for the evaluation of health hazards as may be deemed necessary for the protection of the people of the state.

(6) (a) The State Board of Health shall administer the
local governments and rural water systems improvements loan
program in accordance with the provisions of Section 41-3-16.

(b) The State Board of Health shall have authority:
(i) To enter into capitalization grant agreements
with the United States Environmental Protection Agency, or any
successor agency thereto;

176 (ii) To accept capitalization grant awards made177 under the federal Safe Drinking Water Act, as amended;

(iii) To provide annual reports and audits to the
United States Environmental Protection Agency, as may be required
by federal capitalization grant agreements; and

181 (iv) To establish and collect fees to defray the 182 reasonable costs of administering the revolving fund or emergency 183 fund if the State Board of Health determines that such costs will 184 exceed the limitations established in the federal Safe Drinking 185 Water Act, as amended. The administration fees may be included in 186 loan amounts to loan recipients for the purpose of facilitating payment to the board; however, such fees may not exceed five 187 percent (5%) of the loan amount. 188

189 SECTION 2. This act shall take effect and be in force from 190 and after July 1, 2006.
