SENATE BILL NO. 2238

1 AN ACT TO CREATE NEW SECTION 9-9-18.3, MISSISSIPPI CODE OF 2 1972, TO PROVIDE FOR AN ADDITIONAL COUNTY COURT JUDGE FOR 3 LAUDERDALE COUNTY; AND FOR RELATED PURPOSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
SECTION 1. The following shall be codified as Section
9-9-18.3, Mississippi Code of 1972:

9-9-18.3. (1) In order to relieve the crowded condition of the docket in the county court and in the youth court of Lauderdale County and particularly to facilitate and make possible the trial and disposition of the large number of causes on the docket and in the youth court, there shall be two (2) county judges for Lauderdale County, provided for and elected as herein set out.

For the purposes of nomination and election, the two (2) 14 (2) 15 judgeships shall be separate and distinct, the existing judgeship 16 and its succession to be denominated for purposes of appointment, nomination and election only as "Place One" and the judgeship 17 18 hereby created and its succession for said selfsame purposes and none other to be designated as "Place Two." There shall be no 19 20 distinction whatsoever in the powers, duties and emoluments of the 21 two (2) offices of county judge, except that the county judge of 22 Lauderdale County who has been for the longest time continuously a county judge of the county shall have the right to assign causes, 23 terms and dockets. Should neither judge of the county court have 24 served longer in office than the other, then that judge of this 25 26 county court who has been for the longest time a member of The

27 Mississippi Bar shall have the right to assign causes, terms and 28 dockets.

While there shall be no limitation whatsoever upon the 29 (3) 30 powers and duties of the county judges other than as cast upon 31 them by the Constitution and laws of this state, the county court 32 of Lauderdale County may, in the discretion of the county judge who has been for the longest time continuously a judge of the 33 court, be divided into civil, equity, criminal and youth court 34 divisions as a matter of convenience by the entry of an order upon 35 the minutes of the court. 36

37 (4) The initial holder of the additional judgeship created by this section, or "Place Two," shall be elected in the regular 38 39 election of November 2006; candidates therefor shall qualify to run not later than forty-five (45) days before that election. The 40 person elected shall begin the term of office in January of 2007 41 at the same time as county judges generally, and there shall be no 42 43 vacancy of the office before that time. The two (2) judges shall 44 otherwise be elected, and any vacancy in office filled, as provided for county judges generally. 45

46 The Board of Supervisors of Lauderdale County may, in (5)47 its discretion, set aside, appropriate and expend monies from the 48 general fund to be used in the payment of salaries of judges, clerks, reporters, officers and employees of the youth court 49 division of the county court, including the related facilities of 50 51 the youth court division of the county court, and such funds shall 52 be expended for no other purposes. The county shall not be 53 reimbursed for the amount of any such levy provided for by this section under the terms of the Homestead Exemption Law. 54

55 SECTION 2. The Attorney General of the State of Mississippi 56 shall submit this act, immediately upon approval by the Governor, 57 or upon approval by the Legislature subsequent to a veto, to the 58 Attorney General of the United States or to the United States 59 District Court for the District of Columbia in accordance with the 58 SS02/R658 66/SS02/R658 PAGE 2 60 provisions of the Voting Rights Act of 1965, as amended and 61 extended.

62 **SECTION 3.** This act shall take effect and be in force from 63 and after the date it is effectuated under Section 5 of the Voting 64 Rights Act of 1965, as amended and extended.
