7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
8	SECTION 1. Section 27-19-56.14, Mississippi Code of 1972, is
9	amended as follows:
10	27-19-56.14. (1) * * * Any owner of a motor vehicle who is
11	a member of the Grand Lodge of Mississippi, Free and Accepted
12	Masons, his wife, widow, unmarried daughter or unmarried sister,
13	upon complying with the motor vehicle laws relating to
14	registration and licensing of motor vehicles, and upon payment of
15	the road and bridge privilege taxes, ad valorem taxes and
16	registration fees as prescribed by law for private carriers of
17	passengers, pickup trucks and other noncommercial motor vehicles,
18	and upon payment of an additional annual fee in the amount of
19	Thirty Dollars (\$30.00), shall be entitled to a special license
20	tag which displays the Freemason emblem and displays the words

- (2) The tags shall be of such color and design as the State 22 Tax Commission shall prescribe subject to the approval of the 23

- 25 (3) Application for the special license tags shall be made
- to the county tax collector on forms prescribed by the State Tax 26
- Commission. Applicants for such distinctive license tags shall 27
- present to the issuing official documentation from the Grand Lodge 28

- 30 their membership or relationship to a member in the Grand Lodge of
- 31 Mississippi. The application and the additional fee, less five
- 32 percent (5%) thereof to be retained by the tax collector, shall be
- 33 remitted to the State Tax Commission on a monthly basis as
- 34 prescribed by the commission. The portion of the additional fee
- 35 retained by the tax collector shall be deposited into the county
- 36 general fund.
- 37 (4) The special license tag shall be issued for a one-year
- 38 period. The additional annual fee shall be due and payable at the
- 39 time of renewal registration.
- 40 (5) The State Tax Commission shall deposit all fees into the
- 41 State Treasury on the day received. At the end of each month, the
- 42 State Tax Commission shall certify the total fees collected under
