- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5
- SECTION 1. Section 23-15-225, Mississippi Code of 1972, is 6
- 7 amended as follows:
- 8 23-15-225. (1) The registrar shall be entitled to such
- 9 compensation, payable monthly out of the county treasury, which
- 10 the board of supervisors of the county shall allow on an annual
- basis in the following amounts: 11
- 12 (a) For counties with a total population of more than
- two hundred thousand (200,000), an amount not to exceed 13
- Twenty-nine Thousand Nine Hundred Dollars (\$29,900.00), but not 14
- less than Nine Thousand Two Hundred Dollars (\$9,200.00). 15
- 16 (b) For counties with a total population of more than
- 17 one hundred thousand (100,000) and not more than two hundred
- thousand (200,000), an amount not to exceed Twenty-five Thousand 18
- 19 Three Hundred Dollars (\$25,300.00), but not less than Nine
- Thousand Two Hundred Dollars (\$9,200.00). 20
- 21 (C) For counties with a total population of more than
- fifty thousand (50,000) and not more than one hundred thousand 22
- 23 (100,000), an amount not to exceed Twenty-three Thousand Dollars
- 24 (\$23,000.00), but not less than Nine Thousand Two Hundred Dollars
- (\$9,200.00).25

- 31 (e) For counties with a total population of more than
- 32 twenty-five thousand (25,000) and not more than thirty-five
- 33 thousand (35,000), an amount not to exceed Eighteen Thousand Four

- 50 (\$8,050.00).
- 51 (i) For counties with a total population of not more
- 52 than six thousand (6,000), an amount not to exceed Nine Thousand
- 53 Two Hundred Dollars (\$9,200.00) but not less than Six Thousand
- 54 Three Hundred Twenty-five Dollars (\$6,325.00).
- (j) For counties having two (2) judicial districts, the
- 56 board of supervisors of the county may allow, in addition to the
- 57 sums prescribed herein, in its discretion, an amount not to exceed
- 58 Eleven Thousand Five Hundred Dollars (\$11,500.00).
- 59 (2) In the event of a reregistration within such county, or
- 60 a redistricting which necessitates the hiring of additional deputy
- 61 registrars, the board of supervisors may by contract compensate

- 62 the county registrar amounts in addition to the sums prescribed
- 63 herein, in its discretion.
- 64 (3) As compensation for their services in assisting the
- 65 county election commissioners in performance of their duties in
- 66 the revision of the registration books and the pollbooks of the
- 67 several voting precincts of the several counties and in assisting
- 68 the election commissioners, executive committees or boards of
- 69 supervisors in connection with any election, the registrar shall
- 70 receive the same daily per diem and limitation on meeting days as
- 71 provided for the board of election commissioners as set out in
- 72 Sections 23-15-153 and 23-15-227 to be paid from the general fund
- 73 of the county.
- 74 (4) In any case where an amount has been allowed by the
- 75 board of supervisors pursuant to this section, such amount shall
- 76 not be reduced or terminated during the term for which the
- 77 registrar was elected.
- 78 (5) The circuit clerk shall, in addition to any other
- 79 compensation provided for by law, be entitled to receive as
- 80 compensation from the board of supervisors the amount of Five
- 81 Thousand Dollars (\$5,000.00) per year. This payment shall be for
- 82 the performance of his duties in regard to the conduct of
- 83 elections and the performance of his other duties.
- 84 (6) The municipal clerk shall, in addition to any other
- 85 compensation for performance of duties, be eligible to receive as
- 86 compensation from the municipality's governing authorities a
- 87 reasonable amount of additional compensation for reimbursement of
- 88 costs and for additional duties associated with mail-in
- 89 registration of voters.
- 90 (7) The board of supervisors shall not allow any additional
- 91 compensation authorized under this section for services as county
- 92 registrar to any circuit clerk who is receiving fees as
- 93 compensation for his services equal to the limitation on
- 94 compensation prescribed in Section 9-1-43.

95	SECTION 2. The Attorney General of the State of Mississippi
96	shall submit this act, immediately upon approval by the Governor,
97	or upon approval by the Legislature subsequent to a veto, to the
98	Attorney General of the United States or to the United States
99	District Court for the District of Columbia in accordance with the
100	provisions of the Voting Rights Act of 1965, as amended and
101	extended.
102	SECTION 3. This act shall take effect and be in force from
103	and after the date it is effectuated under Section 5 of the Voting
104	Rights Act of 1965, as amended and extended, or October 1, 2006,
