SENATE BILL NO. 2534 (As Passed the Senate)

AN ACT TO AMEND SECTION 9-1-36, MISSISSIPPI CODE OF 1972, TO INCREASE THE SUPPORT STAFF ALLOWANCE FOR TRIAL COURT JUDGES WITH CERTAIN ATTENDANT RESTRICTIONS; AND FOR RELATED PURPOSES.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 **SECTION 1.** Section 9-1-36, Mississippi Code of 1972, is

6 amended as follows:

7 9-1-36. (1) Each circuit judge and chancellor shall receive

8 an office operating allowance for the expenses of operating the

9 office of the judge, including retaining a law clerk, legal

10 research, stenographic help, stationery, stamps, furniture, office

11 equipment, telephone, office rent and other items and expenditures

12 necessary and incident to maintaining the office of judge. The

13 allowance shall be paid only to the extent of actual expenses

14 incurred by the judge as itemized and certified by the judge to

15 the Supreme Court and then in an amount of Four Thousand Dollars

16 (\$4,000.00) per annum; however, the judge may expend sums in

17 excess thereof from the compensation otherwise provided for his

18 office. No part of this expense or allowance shall be used to pay

19 an official court reporter for services rendered to said court.

20 (2) In addition to the amounts provided for in subsection

21 (1), there is hereby created a separate office allowance fund for

22 the purpose of providing support staff to judges. This fund shall

23 be managed by the Administrative Office of Courts.

24 (3) Each judge who desires to employ support staff after

25 July 1, 1994, shall make application to the Administrative Office

26 of Courts by submitting to the Administrative Office of Courts a

27 proposed personnel plan setting forth what support staff is deemed

- 28 The plan may be submitted by a single judge or by any necessary. 29 combination of judges desiring to share support staff. 30 process of the preparation of the plan, the judges, at their request, may receive advice, suggestions, recommendations and 31 32 other assistance from the Administrative Office of Courts. 33 Administrative Office of Courts must approve the positions, job 34 descriptions and salaries before the positions may be filled. Administrative Office of Courts shall not approve any plan which 35 does not first require the expenditure of the funds in the support 36 staff fund for compensation of any of the support staff before 37 38 expenditure is authorized of county funds for that purpose. Upon approval by the Administrative Office of Courts, the judge or 39 40 judges may appoint the employees to the position or positions, and each employee so appointed will work at the will and pleasure of 41 the judge or judges who appointed him but will be employees of the 42 Administrative Office of Courts. Upon approval by the 43 Administrative Office of Courts, the appointment of any support 44 45 staff shall be evidenced by the entry of an order on the minutes of the court. - (4) The Administrative Office of Courts shall develop and promulgate minimum qualifications for the certification of court administrators. Any court administrator appointed on or after October 1, 1996, shall be required to be certified by the Administrative Office of Courts.

- "Law clerk" means a clerk hired to assist a judge 89
- or judges who has a law degree or who is a full-time law student 90

93 stationery and minor expendable office supplies, procured with

- 94 funds authorized by this section, shall be and forever remain in
- 95 the State of Mississippi to be used by the circuit judge or
- 96 chancellor during the term of his office and thereafter by his
- 97 successors.
- 98 (8) Any circuit judge or chancellor who did not have a
- 99 primary office provided by the county on March 1, 1988, shall be
- 100 allowed an additional Four Thousand Dollars (\$4,000.00) per annum
- 101 to defray the actual expenses incurred by the judge or chancellor
- 102 in maintaining an office; however, any circuit judge or chancellor
- 103 who had a primary office provided by the county on March 1, 1988,
- 104 and who vacated the office space after that date for a legitimate
- 105 reason, as determined by the Department of Finance and
- 106 Administration, shall be allowed the additional office expense
- 107 allowance provided under this subsection. The county in which a
- 108 circuit judge or chancellor sits is authorized to provide funds
- 109 from any available source to assist in defraying the actual
- 110 expenses to maintain an office.
- 111 (9) The Supreme Court, through the Administrative Office of
- 112 Courts, shall submit to the Department of Finance and
- 113 Administration the itemized and certified expenses for office
- 114 operating allowances that are directed to the court pursuant to
- 115 this section.
- 116 (10) The Supreme Court, through the Administrative Office of
- 117 Courts, shall have the power to adopt rules and regulations
- 118 regarding the administration of the office operating allowance
- 119 authorized pursuant to this section.
- 120 **SECTION 2.** This act shall take effect and be in force from
- 121 and after July 1, 2006.
