The distinctive license tags so issued shall be of such color and design as the State Tax Commission, with the advice of the Mississippi Braves baseball team, may prescribe and shall consist of such letters or numbers, or both, as may be necessary to distinguish each license tag.

891 (2) Application for the distinctive license tags authorized 892 by this section shall be made to the county tax collector on forms 893 prescribed by the State Tax Commission. The application and the 894 additional fee imposed under subsection (3) of this section, less 895 Two Dollars (\$2.00) to be retained by the tax collector, shall be 896 S. B. No. 2688 *SS26/R952PS*

- remitted to the State Tax Commission on a monthly basis as
 prescribed by the commission. The portion of the additional fee
 retained by the tax collector shall be deposited into the county
 general fund.
- 900 (3) Beginning with any registration year commencing on or 901 after July 1, 2006, any person applying for a distinctive license 902 tag under this section shall pay an additional fee in the amount 903 of Thirty Dollars (\$30.00) for each distinctive license tag 904 applied for under this section, which shall be in addition to all other taxes and fees. The additional fee paid shall be for a 905 906 period of time to run concurrent with the vehicle's established 907 license tag year. The additional fee is due and payable at the 908 time the original application is made for a distinctive license 909 tag under this section and thereafter annually at the time of renewal registration as long as the owner retains the distinctive 910 911 license tag. If the owner does not wish to retain the distinctive 912 license tag, he must surrender it to the local county tax 913 collector.
- 914 (4) The State Tax Commission shall deposit all fees into the 915 State Treasury on the day collected. At the end of each month, 916 the State Tax Commission shall certify the total fees collected 917 under this section to the State Treasurer who shall distribute 918 such collections as follows:
- ocllected on distinctive license tags issued pursuant to this section shall be distributed to Pearl, Mississippi, to meet obligations incurred by the city in inducing the Mississippi Braves to locate in the city, and to improve infrastructure in the West Pearl Restaurant Tax District created in Chapter 951, Local and Private Laws of 2005.
- 926 (b) One Dollar (\$1.00) of each additional fee collected 927 on distinctive license tags issued pursuant to this section shall

- 928 be deposited into the Mississippi Burn Care Fund created pursuant

- 930 (c) Two Dollars (\$2.00) of each additional fee
- 931 collected on distinctive license tags issued pursuant to this
- 932 section shall be deposited to the credit of the State Highway Fund
- 933 to be expended solely for the repair, maintenance, construction or
- 934 reconstruction of highways.
- 935 (d) One Dollar (\$1.00) of each additional fee collected
- 936 on distinctive license tags issued pursuant to this section shall
- 937 be deposited to the credit of the special fund created in Section
- 938 27-19-44.2.
- 939 (5) A regular license tag must be properly displayed as
- 940 required by law until replaced by a distinctive license tag under
- 941 this section. The regular license tag must be surrendered to the
- 942 tax collector upon issuance of the distinctive license tag under
- 943 this section. The tax collector shall issue up to two (2) license
- 944 decals for each distinctive license tag issued under this section,
- 945 which will expire the same month and year as the regular license
- 946 tag.
- 947 (6) In the case of loss or theft of a distinctive license
- 948 tag issued under this section, the owner may make application and
- 949 affidavit for a replacement distinctive license tag as provided by
- 950 Section 27-19-37. The fee for a replacement distinctive license
- 951 tag shall be Ten Dollars (\$10.00). The tax collector receiving
- 952 such application and affidavit shall be entitled to retain and
- 953 deposit into the county general fund five percent (5%) of the fee
- 954 for such replacement license tag and the remainder shall be
- 955 distributed in the same manner as funds from the sale of regular
- 956 distinctive license tags issued under this section.
- 957 **SECTION** 13. This act shall take effect and be in force from
- 958 and after July 1, 2006.
