## COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 2718

AN ACT TO AUTHORIZE THE STATE BOARD OF EDUCATION TO MAKE CIVIL RIGHTS AND HUMAN RIGHTS EDUCATION A PART OF THE K-12 3 CURRICULUM INSTRUCTION IN THE STATE OF MISSISSIPPI; TO PROVIDE 4 APPROPRIATE GUIDELINES FOR GRADE LEVEL CLASSROOM LEARNING; TO 5 ESTABLISH A MISSISSIPPI CIVIL RIGHTS EDUCATION COMMISSION TO 6 INVENTORY CIVIL RIGHTS EXHIBITS AND RESOURCES AND COORDINATE CIVIL 7 RIGHTS AWARENESS AND EDUCATION IN THE PUBLIC SCHOOLS; AND FOR 8 RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9 SECTION 1. Understanding the important role the Civil Rights 10 11 Movement had on the State of Mississippi and understanding the importance of teaching Mississippi's children all of our history, 12 it is the goal of this Legislature to provide meaningful support 13 to this most important endeavor. Mississippi's central role in 14 the civil rights struggle needs to be formalized and taught as a 15 beacon of hope for all of our citizens. 16 **SECTION 2.** The State Board of Education may make civil 17 18 rights and human rights education a part of the K-12 curriculum of instruction in Mississippi public schools. The State Department 19 of Education shall work with the Mississippi Civil Rights 20 21 Education Commission established in Section 3 in implementing these five (5) guidelines: (a) provide assistance and advice to 22 K-12 schools with respect to the Civil Rights Movement and human 23 rights education and awareness programs; (b) survey and catalog 24 25 the extent to which civil rights and human rights education exists in state curricula; (c) inventory civil rights memorials, exhibits 26 and resources that could be used in classrooms and other 27 28 educational programs; (d) compile a list of volunteers who are 29 willing to share their knowledge and experiences concerning the struggle for civil rights; (e) prepare reports for the Governor 30 \*SS02/R1041CS\* S. - 31 and the State Legislature on the inclusion of civil rights studies
- 32 into the educational systems of the state.
- 33 **SECTION 3.** (1) There is created the Mississippi Civil
- 34 Rights Education Commission. The commission shall be assigned to
- 35 the Office of the Secretary of State for administrative purposes
- 36 only. The commission shall provide or assist education officials
- 37 and other organizations with information, coordination and
- 38 modification of courses or programs that include the Civil Rights
- 39 Movement, and will carry out the specific responsibilities set
- 40 forth in Section 2. In completing this task, the commission may
- 41 act as a liaison with various bodies, including the United States
- 42 Congress, the State Legislature, Teaching for Change, the William
- 43 Winter Institute for Racial Reconciliation, as well as other
- 44 national and international agencies. The commission shall consist
- 45 of no more than fifteen (15) members, eleven (11) positions of
- 46 which will be voluntary, to serve with a term of three (3) years
- 47 on a rotating basis. These positions will be filled by
- 48 application submitted to a joint committee formed by the William
- 49 Winter Institute at the University of Mississippi, Tougaloo
- 50 College, the Oral History Project at the University of Southern
- 51 Mississippi and Jackson State University. Each of these four (4)
- 52 entities shall remain permanent members of this commission, with
- 53 representatives to be appointed by the President or Chancellor of
- 54 the appropriate institution.
- 55 (2) The members of the commission shall be residents of this
- 56 state and shall be appointed with due regard for broad geographic
- 57 representation.
- 58 (3) The commission shall have a chairperson who shall be
- 59 designated by the State Superintendent of Education from the
- 60 commission membership for a term of four (4) years and eight (8)
- 61 members of the commission shall constitute a quorum for the
- 62 transaction of the business of the commission.

63	(4) The Mississippi Commission on Civil Rights Education
64	shall adopt rules and regulations and set standards and policies
65	for the organization, operation, management, budgeting and
66	programs of the commission.

- (5) The commission may apply for and receive gifts, grants
  and donations from any public or private sources, including
  federal and private foundation grants. Members of the commission
  may not be compensated for the performance of their duties except
  from nonstate funds that are specifically available therefor.
- 72 **SECTION 4.** This act shall take effect and be in force from 73 and after July 1, 2006.
