## SENATE BILL NO. 3054

AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE 1 STATE TREASURY TO DEFRAY THE EXPENSES OF THE MISSISSIPPI STATE 2 3 BOARD OF PUBLIC CONTRACTORS FOR FISCAL YEAR 2007. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 4 SECTION 1. The following sum of money, or so much thereof as 5 may be necessary, is hereby appropriated out of any money in the 6 State Treasury to the credit of the Mississippi State Board of 7 8 Public Contractors, for the purpose of defraying the expenses of said board, for the fiscal year beginning July 1, 2006, and ending 9 June 30, 2007..... \$ 1,726,525.00. 10 SECTION 2. Funds are provided herein to adjust the Variable Compensation Plan to ensure that all full-time employees receive a pay increase equal to the realignment component of the Variable Compensation Plan or Twelve Hundred Dollars (\$1,200.00), whichever is greater, beginning on July 1, 2006.

Pursuant to policies established by the State Personnel Board, agency heads may, on a case by case basis and within funds available, recommend equity salary adjustments to Fiscal Year 2006 agency appropriation acts where application of limitations result in awarding one employee a salary increase greater than another employee within the same agency, with the same job classification series and greater longevity.

With the funds herein appropriated, it is the intention of 43 44 the Legislature that it shall be the agency's responsibility to 45 make certain that funds required to be appropriated for "Personal Services" for Fiscal Year 2008 do not exceed Fiscal Year 2007 46 47 funds appropriated for that purpose, unless programs or positions 48 are added to the agency's Fiscal Year 2008 budget by the 49 Mississippi Legislature. Based on data provided by the Legislative Budget Office, the State Personnel Board shall 50 51 determine and publish the projected annual cost to fully fund all 52 appropriated positions in compliance with the provisions of this 53 It shall be the responsibility of the agency head to insure act. 54 that no single personnel action increases this projected annual cost and/or the Fiscal Year 2007 appropriation for "Personal 55 Services" when annualized, with the exception of escalated funds. 56 If, at the time the agency takes any action to change "Personal 57 58 Services," the State Personnel Board determines that the agency 59 has taken an action which would cause the agency to exceed this projected annual cost or the Fiscal Year 2007 "Personal Services" 60 \*SS05/A834\* S. 61 appropriated level, when annualized, then only those actions which 62 reduce the projected annual cost and/or the appropriation 63 requirement will be processed by the State Personnel Board until 64 such time as the requirements of this provision are met.

65 Any transfers or escalations shall be made in accordance with 66 the terms, conditions and procedures established by law or allowable under the terms set forth within this act. The State 67 Personnel Board shall not escalate positions without written 68 approval from the Department of Finance and Administration. 69 The 70 Department of Finance and Administration shall not provide written 71 approval to escalate any funds for salaries and/or positions without proof of availability of new or additional funds above the 72 73 appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

78 SECTION 3. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 79 80 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 81 82 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law. 83 SECTION 4. This act shall take effect and be in force from 84 85 and after July 1, 2006.
