A CONCURRENT RESOLUTION TO CREATE A STUDY COMMITTEE TO STUDY 1 THE AD VALOREM TAXATION OF LAND USED FOR AGRICULTURAL PURPOSES AND 2 TO MAKE RECOMMENDATIONS THEREON TO THE LEGISLATURE. 3 4 WHEREAS, agriculture is vital to the economy of this state and the well-being of its citizens; and 5 6 WHEREAS, complaints have arisen over the years regarding the 7 valuation of land used for agricultural purposes, especially with regard to the valuation of timberland; and 8 9 WHEREAS, it is vital to ensure that the valuation of all land used for agricultural purposes is fair and equitable: 10 NOW, THEREFORE, BE IT RESOLVED BY THE MISSISSIPPI STATE 11 SENATE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That: 12 13 (1) There is hereby created a study committee on the valuation and ad valorem taxation of land used for agricultural 14 15 purposes. The committee shall make a report of its findings and 16 recommendations to the Legislature during the 2007 Regular Session, including any recommended legislation. 17 18 (2) The committee shall be composed of the following 19 members: 20 (a) The Chairman of the Senate Finance Committee; 21 (b) The Chairman of the House Ways and Means Committee; 22 The State Treasurer, or his designee; (C) The Executive Director of the Department of Finance 23 (d)and Administration; 24 25 The State Auditor, or his designee; (e) 26 (f) One (1) member designated by the State Tax 27 Commission;

28 (g) One (1) member designated by the State Board of 29 Public Accountancy;

30 (h) One (1) member designated by the President of The
31 Mississippi Bar from the Taxation Section of The Mississippi Bar;

34 (j) One (1) member designated by the Mississippi35 Municipal Association; and

Supervisors Association;

36 (k) Three (3) representatives of the general public,
37 one (1) designated by the Governor, one (1) by the Lieutenant
38 Governor and one (1) by the Speaker of the House of
39 Representatives.

Appointments shall be made within thirty (30) days after the 40 adoption of this resolution by the Legislature, and, within 41 fifteen (15) days thereafter on a day to be designated jointly by 42 the Lieutenant Governor and the Speaker of the House, the 43 44 committee shall meet and organize by selecting from its membership 45 a chairman and a vice chairman. The vice chairman shall also serve as secretary and shall be responsible for keeping all 46 47 records of the committee. A majority of the members of the 48 committee shall constitute a quorum. In the selection of its 49 officers and the adoption of rules, resolutions and reports, an 50 affirmative vote of a majority of the committee shall be required. All members shall be notified in writing of all meetings, such 51 52 notices to be mailed at least five (5) days prior to the date on which a meeting is to be held. 53

54 (3) The committee shall study and make recommendations with
55 respect to the valuation and ad valorem taxation of land used for
56 agricultural purposes.

57 (4) Members of the committee who are not legislators, state 58 officials or state employees shall be compensated at the per diem 59 rate authorized by Section 25-3-69, Mississippi Code of 1972, and 60 shall be reimbursed in accordance with Section 25-3-41,

Mississippi Code of 1972, for mileage and actual expenses incurred 61 62 in the performance of their duties. Legislative members of the 63 committee shall be paid from the contingent expense funds of their 64 respective houses in the same manner as provided for committee 65 meetings when the Legislature is not in session; however, no per 66 diem or expense for attending meetings of the committee will be paid while the Legislature is in session. No committee member may 67 incur per diem, travel or other expenses unless previously 68 authorized by vote, at a meeting of the committee, which action 69 shall be recorded in the official minutes of the meeting. 70 71 Nonlegislative members shall be paid from any funds made available to the committee for that purpose. 72

73 (5) The committee shall utilize clerical and legal staff already employed by the Legislature and any other staff assistance 74 75 made available to it. To effectuate the purpose of this resolution, any department, division, board, bureau, commission or 76 77 agency of the state or of any political subdivision thereof shall, 78 at the request of the chairman of the committee, provide to the committee such facilities, assistance and data as will enable the 79 80 committee properly to carry out its task.

81 (6) Upon presentation of its report to the 2007 Regular82 Session, the committee shall be dissolved.
