- 3 BY STROKE.
- 4 WHEREAS, according to the American Stroke Association,
- 5 strokes are the third leading cause of death in the United States,
- 6 striking about 700,000 Americans each year; and
- 7 WHEREAS, stroke is a leading cause of serious long-term
- 8 disability in the United States with about 4.8 million stroke
- 9 survivors today; and
- 10 WHEREAS, in 2004, the estimated direct and indirect cost of
- 11 stroke is about \$53.6 Billion; and
- 12 WHEREAS, the Institute of Medicine (IOM) of the National
- 13 Academy of Science has concluded that the fragmentation of the
- 14 delivery of health care services frequently results in sub-optimal
- 15 treatment, safety concerns and inefficient use of health care
- 16 resources; and
- 17 WHEREAS, the IOM recommended the establishment of coordinated
- 18 systems of care that integrate preventative and treatment services
- 19 and promote patient access to evidence-based care; and
- 20 WHEREAS, according to American Stroke Association research, a
- 21 systems approach is necessary to effectuate true change in the way
- 22 stroke is treated statewide so that patients have access to the
- 23 most advanced treatment in centers that are best designed and
- 24 equipped to deal with the critical and time sensitive needs of
- 25 stroke patients; and
- 26 WHEREAS, the main purpose of stroke systems legislation is to
- 27 establish a systems approach to dealing with stroke patients,

- 28 including assessing center designations, EMS protocols and field
- 29 triage, inter-facility stroke transfer, and stroke data
- 30 collection:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 32 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 33 we do hereby urge the State Board of Health to establish a system
- 34 of stroke care for all state residents stricken by stroke and to
- 35 recommend to the Legislature any necessary legislation to
- 36 implement the system of stroke care.
- 37 BE IT FURTHER RESOLVED, That this resolution be forwarded to
- 38 the Executive Director of the State Board of Health and the
- 39 President of the State Board of Health and be made available to
- 40 the Capitol Press Corps.
