10	1981 and a year later the board named Waits Executive Vice
11	President/CEO. During this time, he began a long and
12	distinguished career representing Mississippi's 26 electric
13	cooperatives as their lead lobbyist at the state and national
14	level. Through hard work, dedication and honesty, he earned the
15	respect of all government leaders. Under his leadership, numerous
16	legislative bills of extreme value to electric power associations
17	have passed in Mississippi. He is a well-recognized champion for
18	electric cooperatives and is often called upon to provide
19	testimony, and make presentations and recommendations on behalf of
20	the industry. He is a trusted friend of government leaders; and
21	WHEREAS, he was instrumental in the development of statewide
22	training programs for co-op directors, management and employees.
23	As a spokesperson, he has been recognized for excellent
24	communication programs and possesses an unwavering commitment to
25	spreading the cooperative message to all people; and
26	WHEREAS, upon taking the leadership reins in 1983, Hobson has
27	successfully guided the EPAs and, today, it is recognized as one
