SENATE CONCURRENT RESOLUTION NO. 591

1 A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING THE
2 TUPELO HIGH SCHOOL "LADY WAVE" GIRLS SOCCER TEAM AND COACH SHELLEY
3 MILLER FOR THEIR THIRD MHSAA CLASS 5A STATE CHAMPIONSHIP IN FOUR
4 YEARS.

5 WHEREAS, the Tupelo High School "Lady Wave" Girls Soccer Team
6 put together four playoff wins against the No. 6, No. 2, No. 3 and
7 No. 5 ranked teams to win the 2005 MHSAA Class 5A State
8 Championship; and

9 WHEREAS, this is the Lady Wave's third Class 5A State
10 Championship in four years (2003, 2004 and 2006), a string which
11 began when this year's six seniors on the team were freshmen; and

12 WHEREAS, Seniors Lydia Rice, Laura Hamm, Hannah Weatherly,
13 Anna Merritt Roberts, Molly Lincoln and Ivy Davis have mostly
14 played together since they were seven or eight years old and
15 finished their prep four-year careers with an impressive 76-7-6
16 record, which included a 13-1 State Playoff record; and
