- 3 WHEREAS, former United States Magistrate Judge John R.
- 4 Countiss III died February 22, 2006, at the age of 78; and
- 5 WHEREAS, Judge Countiss was born on August 26, 1927, to John
- 6 R. Countiss, Jr., and Lyneille Butler Countiss, and was a
- 7 life-long resident of Jackson and a member of St. Andrew's
- 8 Episcopal Cathedral; and
- 9 WHEREAS, after graduating from Central High School in the
- 10 Class of 1945, he joined the United States Navy in 1946; and
- 11 WHEREAS, a 1950 graduate of Millsaps College, Countiss earned
- 12 his law degree from the then-Jackson School of Law, graduating Cum
- 13 Laude in 1956; he was admitted to The Mississippi Bar the same
- 14 year, and served as an instructor at the law school from
- 15 1956-1957; and
- 16 WHEREAS, before his appointment to the bench as a
- 17 "Commissioner," the judicial precursor to federal magistrate, he
- 18 practiced law for nine years, first with the law firm of Lee,
- 19 Moore and Countiss and then with the Nichols, Gore and Countiss
- 20 firm; and
- 21 WHEREAS, he married Matelyn "Mimi" Floyd Hines on December 6,
- 22 1962; and
- WHEREAS, he was the longest serving United States Magistrate,
- 24 having been first designated a United States Commissioner for the
- 25 Southern District of Mississippi in 1963, then sworn in as a
- 26 part-time Magistrate Judge in 1974, and appointed full-time

- 27 Magistrate Judge in 1976, in which capacity he continued until his
- 28 retirement on September 30, 1993; and
- 29 WHEREAS, Judge Countiss reentered private practice following
- 30 his retirement from the bench with the law firm of Upshaw,
- 31 Williams, Biggers, Beckham and Riddick; and
- 32 WHEREAS, he was preceded in death by his beloved wife, Mimi,
- 33 and their son, Sean Butler Countiss; and is survived by his
- 34 daughter, Lyneille Countiss Williams; son-in-law, George Williams,
- 35 Jr.; his son, John R. Countiss IV; daughter-in-law, Amy Burns
- 36 Countiss; and six grandchildren: Kaleigh Ann Countiss, Sean
- 37 Matelyn Williams, George Williams III, John R. Countiss V, Rivers
- 38 Matelyn Countiss and Henry Harrison Countiss; and
- 39 WHEREAS, Judge Countiss was known, loved and respected for
- 40 his humor and scholarly appreciation of the law; and
- WHEREAS, his passing leaves a void for his family and many,
- 42 many friends and colleagues; and
- WHEREAS, it is with sadness that we note the passing of this
- 44 outstanding jurist who contributed so much to his profession and
- 45 community:
