- 18 accepted the position of Association Secretary and Manager of the
- 19 high risk property insurance program known as the Alabama
- 20 Insurance Underwriting Association in Foley, Alabama; and
- 21 WHEREAS, he initiated a number of innovative changes to the
- 22 "beach pool" in Alabama which improved the efficiency and system
- 23 operation of the program; and
- 24 WHEREAS, Ron spent more than half his life serving as a
- 25 bridge between consumers and the insurance industry; and

- 26 WHEREAS, he was married to the former Gloria Jean Robinson of
- 27 Utica, Mississippi, and enjoyed many memories together in their
- 28 travels and daily activities; and
- 29 WHEREAS, he was very involved in his church at First Baptist

- 31 choir, taught Sunday School, and served on a number of church
