## REPORT OF CONFERENCE COMMITTEE

## MR. SPEAKER AND MADAM PRESIDENT:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

H. B. No. 1605: Appropriation; Real Estate Commission.

We, therefore, respectfully submit the following report and recommendation:

- 1. That the Senate recede from its Amendment No. 1.
- 2. That the House and Senate adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	Treasury to the credit of the Real Estate License Fund, for the
8	purpose of defraying the expenses of the Mississippi Real Estate
9	Commission for the fiscal year beginning July 1, 2006, and ending
10	June 30, 2007\$ 1,147,616.00.
11	SECTION 2. Of the funds appropriated under the provisions of
12	Section 1, not more than the amounts set forth below shall be
13	expended for the respective major objects or purposes of
14	expenditure:
15	MAJOR OBJECTS OF EXPENDITURE:
16	Personal Services:
17	Salaries, Wages and Fringe Benefits \$ 661,280.00
18	Travel and Subsistence
19	Contractual Services
20	Commodities
21	Capital Outlay:
22	Other Than Equipment

25	Total\$ 1,147,616.00
26	AUTHORIZED POSITIONS:

27	Permanent: Full Time

31	Funds are provided herein to adjust the Variable Compensation
32	Plan to ensure that all full-time employees receive a pay increase
33	equal to the realignment component of the Variable Compensation
34	Plan or Fifteen Hundred Dollars (\$1,500.00), whichever is greater,
35	with not more than one-half $(1/2)$ to be awarded on July 1, 2006,
36	with the remainder to be awarded on January 1, 2007.
37	With the funds herein appropriated, it is the intention of
38	the Legislature that it shall be the agency's responsibility to
39	make certain that funds required to be appropriated for "Personal
40	Services" for Fiscal Year 2008 do not exceed Fiscal Year 2007
41	funds appropriated for that purpose, unless programs or positions
42	are added to the agency's Fiscal Year 2008 budget by the
43	Mississippi Legislature. Based on data provided by the
44	Legislative Budget Office, the State Personnel Board shall
45	determine and publish the projected annual cost to fully fund all
46	appropriated positions in compliance with the provisions of this
47	act. It shall be the responsibility of the agency head to insure
48	that no single personnel action increases this projected annual
49	cost and/or the Fiscal Year 2007 appropriation for "Personal
50	Services" when annualized, with the exception of escalated funds.
51	If, at the time the agency takes any action to change "Personal
52	Services," the State Personnel Board determines that the agency
53	has taken an action which would cause the agency to exceed this
54	projected annual cost or the Fiscal Year 2007 "Personal Services"
55	appropriated level, when annualized, then only those actions which
56	reduce the projected annual cost and/or the appropriation
57	requirement will be processed by the State Personnel Board until
58	such time as the requirements of this provision are met.

Any transfers or escalations shall be made in accordance with 59 60 the terms, conditions and procedures established by law or allowable under the terms set forth within this act. The State 61 62 Personnel Board shall not escalate positions without written 63 approval from the Department of Finance and Administration. 64 Department of Finance and Administration shall not provide written 65 approval to escalate any funds for salaries and/or positions without proof of availability of new or additional funds above the 66 appropriated level. 67 68 No general funds authorized to be expended herein shall be 69 used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this 70 71 act and which are withdrawn and no longer available. SECTION 3. It is the intention of the Legislature that the 72 Mississippi Real Estate Commission shall maintain complete 73 74 accounting and personnel records related to the expenditure of all 75 funds appropriated under this act and that such records shall be in the same format and level of detail as maintained for Fiscal 76 77 Year 2006. It is further the intention of the Legislature that 78 the agency's budget request for Fiscal Year 2008 shall be 79 submitted to the Joint Legislative Budget Committee in a format 80 and level of detail comparable to the format and level of detail 81 provided during the Fiscal Year 2007 budget request process. It is the intention of the Legislature that 82 83 whenever two (2) or more bids are received by this agency for the purchase of commodities or equipment, and whenever all things 84 85 stated in such received bids are equal with respect to price, quality and service, the Mississippi Industries for the Blind 86 shall be given preference. A similar preference shall be given to 87 88 the Mississippi Industries for the Blind whenever purchases are made without competitive bids. 89

90 SECTION 5. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 91 credit of the proper fund or funds as set forth in this act, upon 92 warrants issued by the State Fiscal Officer; and the State Fiscal 93 94 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 95 SECTION 6. This act shall take effect and be in force from 97 and after July 1, 2006.
