REPORT OF CONFERENCE COMMITTEE

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

S. B. No. 3053: Appropriation; Bd. of Public Accountancy.

We, therefore, respectfully submit the following report and recommendation:

- That the House recede from its Amendment No. 1.
- 2. That the Senate and House adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be

41	funds appropriated for that purpose, unless programs or positions			
42	are added to the agency's Fiscal Year 2008 budget by the			
43	Mississippi Legislature. Based on data provided by the			
44	Legislative Budget Office, the State Personnel Board shall			
45	determine and publish the projected annual cost to fully fund all			
46	appropriated positions in compliance with the provisions of this			
47	act. It shall be the responsibility of the agency head to insure			
48	that no single personnel action increases this projected annual			
49	cost and/or the Fiscal Year 2007 appropriation for "Personal			
50	Services" when annualized, with the exception of escalated funds.			
51	If, at the time the agency takes any action to change "Personal			
52	Services," the State Personnel Board determines that the agency			
53	has taken an action which would cause the agency to exceed this			
54	projected annual cost or the Fiscal Year 2007 "Personal Services"			
55	appropriated level, when annualized, then only those actions which			
56	reduce the projecte	ed annual cost and/or the	appropriation	
57	requirement will be	e processed by the State P	ersonnel Board until	
58	such time as the re	equirements of this provis	ion are met.	

- Any transfers or escalations shall be made in accordance with 59 60 the terms, conditions and procedures established by law or allowable under the terms set forth within this act. The State 61 62 Personnel Board shall not escalate positions without written 63 approval from the Department of Finance and Administration. 64 Department of Finance and Administration shall not provide written approval to escalate any funds for salaries and/or positions 65 without proof of availability of new or additional funds above the 66
- 68 No general funds authorized to be expended herein shall be 69 used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this 70 71 act and which are withdrawn and no longer available.
- SECTION 3. It is the intention of the Legislature that 72 73 whenever two (2) or more bids are received by this agency for the purchase of commodities or equipment, and whenever all things 74 75 stated in such received bids are equal with respect to price, quality and service, the Mississippi Industries for the Blind 76 77 shall be given preference. A similar preference shall be given to 78 the Mississippi Industries for the Blind whenever purchases are 79 made without competitive bids.
- 80 SECTION 4. The money herein appropriated shall be paid by 81 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 82 83 warrants issued by the State Fiscal Officer; and the State Fiscal 84 Officer shall issue his warrants upon requisitions signed by the
