AMENDMENT NO. 4

- 1 **AMEND** by inserting the following paragraph after line 22:
- 2 "In addition, after the licensee has fully approved the loan
- 3 to the borrower, the licensee may offer the borrower the
- 4 opportunity to purchase an auto club membership. The licensee
- 5 shall inform the borrower in writing that the purchase of an auto
- 6 club membership is optional and is not required as a condition of
- 7 receiving the loan, and that failure to purchase an auto club
- 8 membership will not affect the licensee's approval of the loan or
- 9 the receipt of the loan by the borrower. If the borrower chooses
- 10 to purchase an auto club membership, the licensee shall allow the
- 11 borrower to pay the cost of the auto club membership using funds
- 12 other than the proceeds of a loan or have the cost deducted from
- 13 the proceeds of any loan obtained from the licensee. The borrower
- 14 shall be allowed to cancel the auto club membership for a full

- 22 the Senate Business and Financial Institutions Committee by
- 23 January 1, 2007. This paragraph shall stand repealed on July 1,
- 24 2008."
- 25 AMEND FURTHER the title by deleting lines 2 through 5 in
- 26 their entirety and inserting in lieu thereof the following:
- 27 "TO AUTHORIZE SMALL LOAN LICENSEES TO OFFER BORROWERS THE
- 28 OPPORTUNITY TO PURCHASE AUTO CLUB MEMBERSHIPS AFTER THE LICENSEE
- 29 HAS FULLY APPROVED THE LOAN TO THE BORROWER; TO REQUIRE THE
- 30 LICENSEE TO INFORM THE BORROWER IN WRITING THAT THE PURCHASE OF AN
- 31 AUTO CLUB MEMBERSHIP IS NOT REQUIRED AS A CONDITION OF RECEIVING
- 32 THE LOAN, AND THAT FAILURE TO PURCHASE AN AUTO CLUB MEMBERSHIP
- 33 WILL NOT AFFECT THE LICENSEE'S APPROVAL OF THE LOAN OR THE RECEIPT
- 34 OF THE LOAN BY THE BORROWER; TO AUTHORIZE THE BORROWER TO CANCEL
- 35 THE AUTO CLUB MEMBERSHIP FOR A FULL REFUND OF THE PURCHASE PRICE
- 36 WITHIN THIRTY DAYS AFTER THE DATE OF PURCHASE; AND FOR RELATED
- 37 PURPOSES."
