## House Amendments to Senate Bill No. 3005

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

## AMENDMENT NO. 1

## Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	General Fund not otherwise appropriated, for the purpose of
8	defraying the expenses of the Commission on Judicial Performance
9	of the State of Mississippi for the fiscal year beginning
10	July 1, 2006, and ending June 30, 2007 \$ 296,872.00.
11	SECTION 2. The following sum, or so much thereof as may be
12	necessary, is hereby appropriated out of any money in the State
13	Treasury to the credit of the Commission on Judicial Performance,
14	for the purpose of defraying the expenses of the Commission on
15	Judicial Performance of the State of Mississippi for the fiscal
16	year beginning July 1, 2006, and ending June 30, 2007
17	\$ 115,911.00.
18	SECTION 3. With the funds appropriated under the provisions
19	of Sections 1 and 2, the following positions are authorized:
20	AUTHORIZED POSITIONS:
21	Permanent: Full Time 4
22	Part Time 0
23	Time-Limited: Full Time 0
24	Part Time 0
25	Any transfers or escalations shall be made in accordance with
26	the terms, conditions and procedures established by law.
27	No general funds authorized to be expended herein shall be
28	used to replace federal funds and/or other special funds which are
29	being used for salaries authorized under the provisions of this
30	act and which are withdrawn and no longer available.

It is the intention of the Legislature that the 31 SECTION 4. 32 Judicial Performance Commission shall maintain complete accounting and personnel records related to the expenditure of all funds 33 34 appropriated under this act and that such records shall be in the same format and level of detail as maintained for Fiscal Year 35 36 2006. It is further the intention of the Legislature that the agency's budget request for Fiscal Year 2008 shall be submitted to 37 38 the Joint Legislative Budget Committee in a format and level of 39 detail comparable to the format and level of detail provided during the Fiscal Year 2007 budget request process. 40

41 SECTION 5. It is the intention of the Legislature that whenever two (2) or more bids are received by this agency for the 42 43 purchase of commodities or equipment, and whenever all things stated in such received bids are equal with respect to price, 44 45 quality and service, the Mississippi Industries for the Blind 46 shall be given preference. A similar preference shall be given to the Mississippi Industries for the Blind whenever purchases are 47 made without competitive bids. 48

49 SECTION 6. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 50 51 credit of the proper fund or funds as set forth in this act, upon 52 warrants issued by the State Fiscal Officer; and the State Fiscal 53 Officer shall issue his warrants upon requisitions signed by the 54 proper person, officer or officers, in the manner provided by law. 55 SECTION 7. This act shall take effect and be in force from and after July 1, 2006. 56
