25 Any transfers or escalations shall be made in accordance with 26 the terms, conditions and procedures established by law.

27 No general funds authorized to be expended herein shall be 28 used to replace federal funds and/or other special funds which are 29 being used for salaries authorized under the provisions of this 30 act and which are withdrawn and no longer available.

SECTION 4. It is the intention of the Legislature that the 31 Judicial Performance Commission shall maintain complete accounting 32 33 and personnel records related to the expenditure of all funds 34 appropriated under this act and that such records shall be in the same format and level of detail as maintained for Fiscal Year 35 36 2006. It is further the intention of the Legislature that the agency's budget request for Fiscal Year 2008 shall be submitted to 37 38 the Joint Legislative Budget Committee in a format and level of detail comparable to the format and level of detail provided 39 during the Fiscal Year 2007 budget request process. 40

41 SECTION 5. It is the intention of the Legislature that whenever two (2) or more bids are received by this agency for the 42 43 purchase of commodities or equipment, and whenever all things stated in such received bids are equal with respect to price, 44 45 quality and service, the Mississippi Industries for the Blind shall be given preference. A similar preference shall be given to 46 47 the Mississippi Industries for the Blind whenever purchases are 48 made without competitive bids.

49 SECTION 6. The money herein appropriated shall be paid by 50 the State Treasurer out of any money in the State Treasury to the 51 credit of the proper fund or funds as set forth in this act, upon 52 warrants issued by the State Fiscal Officer; and the State Fiscal 53 Officer shall issue his warrants upon requisitions signed by the 54 proper person, officer or officers, in the manner provided by law.
