COMMITTEE AMENDMENT NO 1 PROPOSED TO**

Senate Bill No. 3009

BY: Committee

**Amend by striking all after the enacting clause and inserting
in lieu thereof the following:**

6 **SECTION 1.** The following sum, or so much thereof as may be
7 necessary, is hereby appropriated out of any money in the State
8 General Fund not otherwise appropriated, for expenses of the
9 Executive Department, being the Governor's office and staff, for
10 the fiscal year beginning July 1, 2006, and ending June 30, 2007,
11 \$ 1,785,055.00.

12 **SECTION 2.** The following sum, or so much thereof as may be
13 necessary, is hereby appropriated out of any money in the State
14 Treasury to the credit of the Governor's Office for the purpose of
15 defraying the expenses incurred by the Executive Department, being
16 the Governor's office and staff, for the fiscal year beginning
17 July 1, 2006, and ending June 30, 2007.....\$ 595,453.00.

18 **SECTION 3.** With the funds appropriated under the provisions
19 of Sections 1 and 2, not more than the amounts set forth below
20 shall be expended for the respective major objects or purposes of
21 expenditure:

48 **SECTION 4.** The following sum, or so much thereof as may be
49 necessary, is hereby appropriated out of any money in the State
50 General Fund not otherwise appropriated, for expenses incidental
51 to the proper operation of the Governor's Mansion and residence of
52 the Governor for the fiscal year beginning July 1, 2006, and
53 ending June 30, 2007..... \$ 378,237.00.

54 **SECTION 5.** With the funds appropriated under the provisions
55 of Section 4, not more than the amounts set forth below shall be

56 expended for the respective major objects or purposes of
57 expenditure:

77 used to replace federal funds and/or other special funds which are
78 being used for salaries authorized under the provisions of this
79 act and which are withdrawn and no longer available.

80 **SECTION 6.** It is the intention of the Legislature that
81 whenever two (2) or more bids are received by this agency for the
82 purchase of commodities or equipment, and whenever all things
83 stated in such received bids are equal with respect to price,
84 quality and service, the Mississippi Industries for the Blind
85 shall be given preference. A similar preference shall be given to
86 the Mississippi Industries for the Blind whenever purchases are
87 made without competitive bids.

88 **SECTION 7.** The money herein appropriated shall be paid by
89 the State Treasurer out of any money in the State Treasury to the
90 credit of the proper fund or funds as set forth in this act, upon
91 warrants issued by the State Fiscal Officer; and the State Fiscal
92 Officer shall issue his warrants upon requisitions signed by the
93 proper person, officer or officers, in the manner provided by law.

94 **SECTION 8.** This act shall take effect and be in force from
95 and after July 1, 2006.
