Senate Amendments to House Bill No. 1590

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

6	SECTION 1. The following sum, or so much of it as may be
7	necessary, is appropriated out of any money in the special fund in
8	the State Treasury to the credit of the Board of Examiners for
9	Social Workers and Marriage and Family Therapists for the purpose
10	of defraying the expenses of the board for the fiscal year
11	beginning July 1, 2006, and ending June 30, 2007

13	SECTION 2. Of the funds appropriated under the provisions of
14	Section 1, not more than the amounts set forth below shall be
15	expended for the respective major objects or purposes of

32 Part Time..... 0 33 Funds are provided herein to adjust the Variable Compensation Plan to ensure that all full-time employees receive a pay increase 34 35 equal to the realignment component of the Variable Compensation Plan or Twelve Hundred Dollars (\$1,200.00), whichever is greater, 36 37 beginning on July 1, 2006. Pursuant to policies established by the State Personnel 38 39 Board, agency heads may, on a case by case basis and within funds 40 available, recommend equity salary adjustments to Fiscal Year 2006 41 agency appropriation acts where application of limitations result 42 in awarding one employee a salary increase greater than another 43 employee within the same agency, with the same job classification 44 series and greater longevity. With the funds herein appropriated, it is the intention of 45 46 the Legislature that it shall be the agency's responsibility to 47 make certain that funds required to be appropriated for "Personal Services" for Fiscal Year 2008 do not exceed Fiscal Year 2007 48 49 funds appropriated for that purpose, unless programs or positions 50 are added to the agency's Fiscal Year 2008 budget by the 51 Mississippi Legislature. Based on data provided by the Legislative Budget Office, the State Personnel Board shall 52 53 determine and publish the projected annual cost to fully fund all 54 appropriated positions in compliance with the provisions of this 55 It shall be the responsibility of the agency head to insure 56 that no single personnel action increases this projected annual 57 cost and/or the Fiscal Year 2007 appropriation for "Personal Services" when annualized, with the exception of escalated funds. 58 59 If, at the time the agency takes any action to change "Personal 60 Services, " the State Personnel Board determines that the agency 61 has taken an action which would cause the agency to exceed this projected annual cost or the Fiscal Year 2007 "Personal Services" 62 appropriated level, when annualized, then only those actions which 63 64 reduce the projected annual cost and/or the appropriation requirement will be processed by the State Personnel Board until 65 66 such time as the requirements of this provision are met.

67 Any transfers or escalations shall be made in accordance with

68 the terms, conditions and procedures established by law or

- allowable under the terms set forth within this act. The State 69
- 70 Personnel Board shall not escalate positions without written
- approval from the Department of Finance and Administration. 71 The
- 72 Department of Finance and Administration shall not provide written
- 73 approval to escalate any funds for salaries and/or positions
- 74 without proof of availability of new or additional funds above the
- 75 appropriated level.
- No general funds authorized to be expended herein shall be 76
- 77 used to replace federal funds and/or other special funds which are
- being used for salaries authorized under the provisions of this 78
- 79 act and which are withdrawn and no longer available.
- 80 SECTION 3. It is the intention of the Legislature that the
- 81 Board of Examiners for Social Workers and Marriage and Family
- 82 Therapists shall maintain complete accounting and personnel
- records related to the expenditure of all funds appropriated under 83
- 84 this act and that such records shall be in the same format and
- 85 level of detail as maintained for Fiscal Year 2006. It is further
- 86 the intention of the Legislature that the agency's budget request
- 87 for Fiscal Year 2008 shall be submitted to the Joint Legislative
- 88 Budget Committee in a format and level of detail comparable to the
- 89 format and level of detail provided during the Fiscal Year 2007
- 90 budget request process.
- 91 SECTION 4. It is the intention of the Legislature that
- 92 whenever two (2) or more bids are received by this agency for the
- 93 purchase of commodities or equipment, and whenever all things
- 94 stated in such received bids are equal with respect to price,
- 95 quality and service, the Mississippi Industries for the Blind
- 96 shall be given preference. A similar preference shall be given to
- the Mississippi Industries for the Blind whenever purchases are 97
- 98 made without competitive bids.
- 99 SECTION 5. The money herein appropriated shall be paid by
- 100 the State Treasurer out of any money in the State Treasury to the
- credit of the proper fund or funds as set forth in this act, upon 101

warrants issued by the State Fiscal Officer; and the State Fiscal
Officer shall issue his warrants upon requisitions signed by the
proper person, officer or officers, in the manner provided by law.

SECTION 6. This act shall take effect and be in force from
and after July 1, 2006.
