Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 6 **SECTION 1.** Section 43-13-405, Mississippi Code of 1972, is 7 amended as follows: 8 43-13-405. (1) In accordance with the purposes of this
- 9 article, there is established in the State Treasury the Health
- 10 Care Trust Fund, into which shall be deposited Two Hundred Eighty
- 11 Million Dollars (\$280,000,000.00) of the funds received by the
- 12 State of Mississippi as a result of the tobacco settlement as of
- 13 the end of fiscal year 1999, and all tobacco settlement
- 14 installment payments made in subsequent years for which the use or
- 15 purpose for expenditure is not restricted by the terms of the
- 16 settlement, except as otherwise provided in Section 43-13-407(2)
- 17 and (3). All income from the investment of the funds in the
- 18 Health Care Trust Fund shall be credited to the account of the
- 19 Health Care Trust Fund. The funds in the Health Care Trust Fund
- 20 at the end of a fiscal year shall not lapse into the State General
- 21 Fund.
- 22 (2) The Health Care Trust Fund shall remain inviolate and
- 23 shall never be expended, except as provided in this article. The
- 24 Legislature shall appropriate from the Health Care Trust Fund such

- 25 sums as are necessary to recoup any funds lost as a result of any
- of the following actions: 26
- (a) The federal Centers for Medicare and Medicaid 27
- 28 Services, or other agency of the federal government, is successful
- 29 in recouping tobacco settlement funds from the State of
- 30 Mississippi;
- (b) The federal share of funds for the support of the 31
- 32 Mississippi Medicaid Program is reduced directly or indirectly as
- a result of the tobacco settlement; 33
- (c) Federal funding for any other program is reduced as 34
- 35 a result of the tobacco settlement; or
- (d) Tobacco cessation programs are mandated by the 36
- 37 federal government or court order.
- This section shall stand repealed on July 1, 2011. 38
- SECTION 2. This act shall take effect and be in force from 39
- and after July 1, 2006. 40
