Adopted COMMITTEE AMENDMENT NO 1 PROPOSED TO

House Bill No. 935

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

6 SECTION 1. Section 49-5-107, Mississippi Code of 1972, is 7 amended as follows: 49-5-107. (a) The commission shall conduct investigations 8 9 on nongame wildlife in order to develop information relating to population, distribution, habitat needs, limiting factors, and 10 other biological and ecological data to determine management 11 measures necessary for their continued ability to sustain 12 themselves successfully. On the basis of such determinations the 13 commission shall issue proposed regulations * * * and develop 14 15 management programs, designed to insure the continued ability of 16 nongame wildlife to perpetuate themselves successfully. proposed regulations shall set forth species or subspecies of 17 nongame wildlife which the commission deems in need of management 18 pursuant to this section, giving their common and scientific names 19 by species and subspecies. The commission shall conduct ongoing 20 21 investigations of nongame wildlife and may from time to time amend 22 such regulations by adding or deleting * * * species or subspecies 23 of nongame wildlife.

- 24 (b) The commission shall by such regulations establish
- 25 proposed limitations relating to taking, possession,
- 26 transportation, exportation, processing, purchasing, sale or offer
- 27 for sale, or shipment as may be deemed necessary to manage such
- 28 nongame wildlife. Such regulation shall become effective sixty
- 29 (60) days after being proposed during which period public comment
- 30 shall be solicited and received. The commission may hold a public
- 31 hearing if deemed appropriate. On the basis of public comments
- 32 received or the testimony at any such hearing the commission may
- 33 make such changes in the proposed regulation as are consistent
- 34 with effective management of nongame wildlife.
- 35 (c) Except as provided in regulations issued by the
- 36 commission, it shall be unlawful for any person to take, possess,
- 37 transport, export, process, purchase, sell or offer for sale or
- 38 ship nongame wildlife deemed by the commission to be in need of
- 39 management pursuant to this section. Subject to the same
- 40 exception, it shall further be unlawful for any common or contract
- 41 carrier knowingly to transport or receive for shipment nongame
- 42 wildlife deemed by the commission to be in need of management
- 43 pursuant to this section.
- 44 **SECTION 2.** This act shall take effect and be in force from
- 45 and after its passage.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:
