5	SECTION 1. The following sum, or so much thereof as may be

16	for the purpose of defraying the expenses of the commission for

Funds are provided herein to adjust the Variable Compensation Plan to ensure that all full-time employees receive a pay increase equal to the realignment component of the Variable Compensation Plan or Twelve Hundred Dollars (\$1,200.00), whichever is greater, beginning on July 1, 2006.

Pursuant to policies established by the State Personnel Board, agency heads may, on a case by case basis and within funds available, recommend equity salary adjustments to Fiscal Year 2006 agency appropriation acts where application of limitations result in awarding one employee a salary increase greater than another employee within the same agency, with the same job classification series and greater longevity.

With the funds herein appropriated, it is the intention of 38 the Legislature that it shall be the agency's responsibility to 39 40 make certain that funds required to be appropriated for "Personal 41 Services" for Fiscal Year 2008 do not exceed Fiscal Year 2007 funds appropriated for that purpose, unless programs or positions 42 43 are added to the agency's Fiscal Year 2008 budget by the 44 Mississippi Legislature. Based on data provided by the 45 Legislative Budget Office, the State Personnel Board shall determine and publish the projected annual cost to fully fund all 46 47 appropriated positions in compliance with the provisions of this 48 It shall be the responsibility of the agency head to insure act. that no single personnel action increases this projected annual 49 50 cost and/or the Fiscal Year 2007 appropriation for "Personal Services" when annualized, with the exception of escalated funds. 51 52 If, at the time the agency takes any action to change "Personal Services," the State Personnel Board determines that the agency 53 54 has taken an action which would cause the agency to exceed this 55 projected annual cost or the Fiscal Year 2007 "Personal Services"

appropriated level, when annualized, then only those actions which reduce the projected annual cost and/or the appropriation requirement will be processed by the State Personnel Board until such time as the requirements of this provision are met.

60 Any transfers or escalations shall be made in accordance with 61 the terms, conditions and procedures established by law or allowable under the terms set forth within this act. The State 62 Personnel Board shall not escalate positions without written 63 64 approval from the Department of Finance and Administration. The 65 Department of Finance and Administration shall not provide written 66 approval to escalate any funds for salaries and/or positions without proof of availability of new or additional funds above the 67 68 appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

73 SECTION 4. It is the intention of the Legislature that the 74 Mississippi Arts Commission shall maintain complete accounting and 75 personnel records related to the expenditure of all funds 76 appropriated under this act and that such records shall be in the 77 same format and level of detail as maintained for Fiscal Year 78 2006. It is further the intention of the Legislature that the agency's budget request for Fiscal Year 2008 shall be submitted to 79 80 the Joint Legislative Budget Committee in a format and level of detail comparable to the format and level of detail provided 81 82 during the Fiscal Year 2007 budget request process.

83 SECTION 5. Of the funds appropriated under the provisions of 84 Section 2, funds in the amount of Four Hundred Fifty Thousand 85 Dollars (\$450,000.00) shall be derived from the Education 86 Enhancement Fund pursuant to Sections 27-65-75 and 27-67-31, 87 Mississippi Code of 1972, for the following:

It is the intention of the Legislature that the 92 Arts Commission shall have the authority to transfer dollars 93 appropriated herein designated for the "Challenge Program," specific amounts to a special fund in the State Treasury called 94 95 the Arts Commission Challenge Initiative Fund. The unexpended 96 amounts remaining in the fund at the end of a fiscal year shall not lapse into the State General Fund and may be expended by the 97 98 commission in subsequent fiscal years upon appropriation of the Legislature. Any interest earned on the fund shall be deposited 99 100 to the credit of the fund and may be disbursed by the commission 101 upon appropriations of the Legislature. It is the intention of 102 the Legislature that the commission may award grants to arts 103 organizations from monies in the fund and the grantees will be 104 required to provide matching funds for the grants in an amount of 105 not less than two (2) times the amount of the grant.

SECTION 7. It is the intention of the Legislature that the Mississippi Arts Commission shall have the authority to escalate its budget and expend funds from any source available not to exceed Five Hundred Thousand Dollars (\$500,000.00), that may become available to the commission in accordance with the rules and regulations of the Department of Finance and Administration in a manner consistent with the escalation of federal funds.

SECTION 8. It is the intention of the Legislature that whenever two (2) or more bids are received by this agency for the purchase of commodities or equipment, and whenever all things stated in such received bids are equal with respect to price, quality and service, the Mississippi Industries for the Blind shall be given preference. A similar preference shall be given to 119 the Mississippi Industries for the Blind whenever purchases are 120 made without competitive bids.

121 SECTION 9. The money herein appropriated shall be paid by 122 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 123 124 warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the 125 proper person, officer or officers, in the manner provided by law. 126 SECTION 10. This act shall take effect and be in force from 127 and after July 1, 2006. 128
