HOUSE BILL NO. 20

AN ACT TO AMEND CHAPTER 883, LOCAL AND PRIVATE LAWS OF 1982,
TO REVISE THE PURPOSES AND USES FOR WHICH THE BOARD OF TRUSTEES OF
THE SIMPSON COUNTY ECONOMIC DEVELOPMENT DISTRICT MAY SELL, LEASE,
CONVEY OR OTHERWISE DISPOSE OF SITES WITHIN INDUSTRIAL PARKS; AND
FOR RELATED PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Chapter 883, Local and Private Laws of 1982, is
- 8 amended as follows:
- 9 Section 1. (1) For the purposes set forth in subsection (2)
- 10 of this section, the Board of Supervisors of Simpson County,
- 11 Mississippi, may, in its discretion, expend, and authorize the
- 12 trustees of the Simpson County Economic Development District to
- 13 expend any monies in the county treasury available for economic
- 14 and industrial development.

- 15 (2) Such monies may be expended for the acquisition,
- 16 development and improvement of real estate within Simpson County,
- 17 Mississippi, to be used for an industrial park or parks, and for
- 18 such purposes the Simpson County Economic Development District
- 19 shall have the authority to own, hold, maintain, control and
- 20 develop such real estate; to engage in works of internal
- 21 improvement therefor, including, but not limited to, construction,
- 22 or contracting for the construction of streets, roads, railroads,
- 23 spur tracks, site improvements, water, sewerage, drainage,
- 24 pollution control and other related facilities necessary or
- 25 required for industrial use and development of industrial park
- 26 complexes; to acquire, purchase, install, lease, construct, own,
- 27 hold, equip, control, maintain, use, operate and repair other
- 28 structures and facilities necessary and convenient for the

- 29 planning, development, use, operation and maintenance of such
- 30 industrial park or parks, including, but not limited to, utility
- 31 installations, elevators, compressors, warehouses, buildings, and
- 32 air, rail and other transportation terminals and pollution control
- 33 facilities.
- 34 (3) The Trustees of the Simpson County Economic Development
- 35 District are authorized and empowered to sell, lease, trade,
- 36 exchange or otherwise dispose of * * * sites situated within
- 37 industrial parks to individuals, firms or corporations, public or
- 38 private, for industrial, warehouse, and other use, including, but
- 39 not limited to, call and data information centers, upon such terms
- 40 and conditions, and for such considerations, with such safeguards
- 41 as will best promote and protect the public interest, convenience
- 42 and necessity, and to execute deeds, leases, contracts, easements
- 43 and other legal instruments necessary or convenient therefor.
- 44 **SECTION 2.** This act shall take effect and be in force from
- 45 and after its passage.
