1 2 3 4	A CONCURRENT RESOLUTION COMMENDING THE DEDICATED PUBLIC SERVICE OF GORDON A. COTTON, LONGTIME CURATOR AND DIRECTOR OF THE OLD COURTHOUSE MUSEUM IN VICKSBURG, MISSISSIPPI, ON THE OCCASION OF HIS RETIREMENT.
5	WHEREAS, Gordon A. Cotton, a native of Yokena, Warren County,
6	Mississippi, grew up in the finest traditions of the South,
7	attending public schools, then colleges for his bachelor's and
8	master's degrees, and became a history teacher so that the stories
9	of the American people could be known, respected, and preserved,
10	and serve an instructive purpose to us all; and
11	WHEREAS, Gordon A. Cotton later became a journalist, known
12	widely for his portraits and narratives about both famous
13	Mississippians and Mississippians who should be famous; and
14	WHEREAS, thirty years ago, Gordon A. Cotton accepted and has
15	served faithfully in his destined career as Curator and Director
16	of the Old Courthouse Museum - Eva W. Davis Memorial in Vicksburg,
17	Mississippi; and
18	WHEREAS, the museum is housed in the former Warren County
19	Courthouse, left vacant after county business operations were
20	moved across Cherry Street in the early 1940s. The building dates
21	to 1860 and was the site of the city's formal surrender to Union
22	forces on July 4, 1863. In addition to legal, land and other
23	records available to researchers, collections housed in the museum

include artifacts from pre-Columbian Mississippi, up to and

through the pioneer days. One room is dedicated to Vicksburg's

history of the War Between The States, and a room off the restored

courtroom on the second floor is dedicated to Jefferson Davis, a

- 30 WHEREAS, the Old Courthouse Museum Eva W. Davis Memorial,
- 31 designated as a National Landmark, and the Vicksburg National
- 32 Military Park are the area's top tourist attractions; and
- 33 WHEREAS, Gordon A. Cotton has continued to write, both a
- 34 weekly newspaper column centered on Warren County and Mississippi
- 35 History; and numerous books on a variety of topics; and
- 36 WHEREAS, in each and every writing, Gordon A. Cotton has
- 37 shown a respect and admiration for the people who, as individuals,
- 38 helped their neighbors, their state and their nation; and
- 39 WHEREAS, Gordon A. Cotton has been an exceptional Ambassador
- 40 for Warren County and Mississippi, often quoted and appearing in
- 41 national publications and films related to Mississippi History;

- WHEREAS, Gordon A. Cotton has been previously honored and
- 44 recognized by a multitude of organizations, including the
- 45 Mississippi Historical Society, the Mississippi Museums
- 46 Association and the Mississippi Department of Archives and

- WHEREAS, Gordon A. Cotton is widely known as a person of good
- 49 humor and sincerity, as a skilled craftsman and dedicated worker,
- 50 as a Deacon in his church and as a compassionate and faithful
- 51 friend to hundreds of people:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 53 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 54 we do hereby recognize and applaud the effective public service
- 55 Gordon A. Cotton has provided through the years in both his
- 56 exemplary citizenship and scholarly work in the preservation and
- 57 in the presentation of the history of the people of Mississippi,
- 58 and extend to him and his family the best wishes of the
- 59 Legislature on the occasion of his retirement after 30 years as
