- 13 this brave, resilient little girl was rescued from certain death;

- 17 unselfish action, including:
- Personal acknowledgement from President Richard M. Nixon
- 19 in 1973 for bravery and heroic service beyond the call of duty;
- Selection as Officer of the Year for 1974 by the
- 21 Mississippi Highway Patrol for bravery and heroic rescue in the
- 22 line of duty in the rescue of Curtis Pitner from a burning home on
- 23 January 25, 1973;
- Presentation of Senate Concurrent Resolution No. 583
- 25 (1974) and presentation of the Outstanding Mississippian Award
- 26 from Governor Bill Waller in 1974 for the Pitner incident; and

- WHEREAS, Sheriff Dickerson successfully graduated from the 27 28 U.S. Army Missile School at Redstone Arsenal in Alabama in 1973,
- 29 was promoted to the Criminal Investigation Unit in the Mississippi
- 30 Highway Patrol in 1979, was promoted to North Mississippi District
- 31 Superintendent of the Criminal Investigation Division in 1983,
- 32 graduated from the FBI National Academy in 1984, retired from the
- Mississippi Highway Patrol in 1995, and was elected Marshall 33
- County Sheriff where he is presently in his third term; and 34
- WHEREAS, it is with great pride that we recognize the 35
- dedication and special accomplishments of this individual whose 36
- 37 personal courage has brought credit upon the law enforcement
