HOUSE BILL NO. 314

- 1 AN ACT TO CREATE THE MISSISSIPPI SMOKE FREE FAMILY RESTAURANT
- 2 ACT; TO PROVIDE DEFINITIONS OF CERTAIN TERMS; TO PROHIBIT SMOKING
- 3 IN ALL FAMILY RESTAURANTS IN THE STATE OF MISSISSIPPI; TO PROVIDE
- 4 FOR THE POSTING OF NO SMOKING SIGNS AT FAMILY RESTAURANTS; TO
- 5 DIRECT THE STATE BOARD OF HEALTH TO ADOPT REGULATIONS AND
- 6 PENALTIES REGARDING VIOLATIONS OF THIS ACT; AND FOR RELATED
- 7 PURPOSES.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** This act shall be known and may be cited as the
- 10 "Mississippi Smoke Free Family Restaurant Act."
- 11 **SECTION 2.** As used in this act, the following words and
- 12 phrases shall have the meanings ascribed in this section, unless
- 13 the context clearly indicates otherwise:
- 14 (a) "Enclosed" means enclosed on all sides by solid
- 15 walls or windows, excluding doors or passageways, that extend from
- 16 the floor to the ceiling.
- 17 (b) "Family restaurant" means any indoor or enclosed
- 18 eating establishment that gives or offers for sale food to the
- 19 public and allows persons under eighteen (18) years of age to
- 20 enter and be served.
- 21 (c) "Smoking" means inhaling, exhaling, burning,
- 22 carrying or otherwise possessing any lighted cigarette, cigar,
- 23 pipe or any other object or device of any form that contains
- 24 lighted tobacco or any other smoking product.
- 25 <u>SECTION 3.</u> (1) Smoking is prohibited in all family
- 26 restaurants in the State of Mississippi.
- 27 (2) Notwithstanding the provision of subsection (1) of this
- 28 section, a family restaurant is not subject to the smoking

- 29 restrictions of this act while the entire restaurant is being used
- 30 for a private function.
- 31 (3) Every family restaurant shall have posted at every
- 32 entrance a conspicuous sign clearly stating that smoking is
- 33 prohibited in the restaurant.
- 34 **SECTION 4.** The State Board of Health shall adopt and
- 35 promulgate regulations and penalties regarding the violations of
- 36 this act not later than ninety (90) days after the effective date
- 37 of this act.
- 38 **SECTION 5.** This act shall not be interpreted or construed to
- 39 prohibit any municipality or county from adopting ordinances with
- 40 regard to smoking in restaurants or other public places.
- 41 **SECTION 6.** This act shall take effect and be in force from
- 42 and after its passage.
