COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 566

AN ACT TO CODIFY NEW SECTION 41-57-31, MISSISSIPPI CODE OF 1972, TO PROVIDE FOR THE ISSUANCE OF A "CERTIFICATE OF BIRTH 3 RESULTING IN STILLBIRTH" BY THE BUREAU OF VITAL STATISTICS OF THE STATE DEPARTMENT OF HEALTH UPON THE REQUEST OF A PARENT OF A STILLBORN CHILD; TO PROVIDE THAT A PARENT MAY REQUEST THE ISSUANCE 6 OF THIS CERTIFICATE WITHOUT REGARD TO WHETHER THE DEATH OCCURRED 7 BEFORE OR AFTER THE EFFECTIVE DATE OF THIS ACT; TO PROVIDE THAT 8 THE PERSON WHO IS REQUIRED TO FILE A DEATH CERTIFICATE SHALL 9 ADVISE THE PARENT OR PARENTS OF A STILLBORN CHILD ABOUT THE AVAILABILITY OF THIS CERTIFICATE AND HOW TO REQUEST THE ISSUANCE 10 11 OF THE CERTIFICATE; TO PROVIDE THAT THE STATE DEPARTMENT OF HEALTH SHALL PRESCRIBE THE FORM AND CONTENT OF THE CERTIFICATE AND 12 SPECIFY THE INFORMATION NECESSARY TO PREPARE THE CERTIFICATE; TO AUTHORIZE THE STATE BOARD OF HEALTH TO ADOPT ANY RULES OR 13 14 15 REGULATIONS NECESSARY TO ADMINISTER THIS SECTION; AND FOR RELATED 16 PURPOSES. 17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. The following shall be codified as Section

- 20 41-57-31. (1) As used in this section, the following terms
- shall be defined as provided in this section, unless the context 21
- 22 otherwise requires:
- 23 (a) "Certificate of birth resulting in stillbirth"
- means a birth certificate issued to record and memorialize the 2.4
- birth of a stillborn child. 25
- (b) "Stillbirth" or "stillborn" means an unintended, 26
- 27 intrauterine fetal death occurring in this state after a
- gestational age of not less than twenty (20) completed weeks. 28
- (2) For any stillborn child in this state, the Bureau of 29
- 30 Vital Statistics shall issue a certificate of birth resulting in
- 31 stillbirth upon the request of a parent named on the death
- 32 certificate, within sixty (60) days of the date of the request. A
- parent may request the Bureau of Vital Statistics to issue a 33
- 34 certificate of birth resulting in stillbirth without regard to

- 35 whether the death occurred on, before, or after July 1, 2007, and
- 36 without regard to the date on which the death certificate was
- 37 issued.
- 38 (3) The person who is required to file a death certificate
- 39 under this chapter shall advise the parent or parents of a
- 40 stillborn child:
- 41 (a) That a parent may, but is not required to, request
- 42 the preparation of a certificate of birth resulting in stillbirth;
- (b) That a parent may obtain a certificate of birth
- 44 resulting in stillbirth by contacting the Bureau of Vital
- 45 Statistics to request the certificate and paying the required fee;
- 46 and
- 47 (c) How a parent may contact the Bureau of Vital
- 48 Statistics to request a certificate of birth resulting in
- 49 stillbirth.
- 50 (4) A parent may provide a name for a stillborn child on the
- 51 request for a certificate of birth resulting in stillbirth. The
- 52 name of the stillborn child provided on or later added by
- 53 amendment to the certificate shall be the same name as placed on
- 54 the original or amended death certificate. If the requesting
- 55 parent does not wish to provide a name, the Bureau of Vital
- 56 Statistics shall fill in the certificate with the name "baby boy"
- or "baby girl" and the last name of the parent.
- 58 (5) Not later than September 1, 2007, the State Department
- 59 of Health shall prescribe the form and content of a certificate of
- 60 birth resulting in stillbirth and shall specify the information
- 61 necessary to prepare the certificate. In addition to any other
- 62 information required to be on the certificate, the certificate
- 63 shall include:
- 64 (a) The date of the stillbirth;
- (b) The county in which the stillbirth occurred;
- 66 (c) The state file number of the corresponding death

- (d) The following statement: "This certificate is not
- 69 proof of live birth."
- 70 (6) Upon issuance of a certificate of birth resulting in
- 71 stillbirth to a parent, the Bureau of Vital Statistics shall file
- 72 an exact copy of the certificate with the local registrar of the
- 73 registration district in which the stillbirth occurred. The local
- 74 registrar shall file the certificate of birth resulting in
- 75 stillbirth with the death certificate.
- 76 (7) The Bureau of Vital Statistics may not use a certificate
- 77 of birth resulting in stillbirth to calculate live birth
- 78 statistics.
- 79 (8) The State Board of Health may adopt any rules or
- 80 regulations necessary to administer this section.
- 81 **SECTION 2.** This act shall take effect and be in force from
- 82 and after July 1, 2007.
