HOUSE BILL NO. 878

AN ACT TO REQUIRE OWNERS OF ALL NONPRODUCING MINERAL ESTATES AND LEASEHOLD INTERESTS IN MINERALS OWNED SEPARATELY AND APART 3 FROM THE SURFACE ESTATE TO PAY A CERTAIN PORTION OF PROPERTY TAXES; TO PROVIDE THAT WHERE THE TAX BECOMES DELINQUENT THE MINERAL ESTATE OR LEASEHOLD INTEREST SHALL REVERT TO THE SURFACE 6 OWNER; TO AMEND SECTION 27-31-85, MISSISSIPPI CODE OF 1972, IN CONFORMITY TO THE PROVISIONS OF THIS ACT; TO REPEAL SECTIONS 7 27-31-73 AND 27-31-75, MISSISSIPPI CODE OF 1972, WHICH RELATE TO 8 9 THE EXEMPTION OF NONPRODUCING MINERAL AND LEASEHOLD INTERESTS FROM AD VALOREM TAXES; AND FOR RELATED PURPOSES. 10

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 12 **SECTION 1.** (1) From and after January 1, 2008, all owners
- 13 of nonproducing mineral estates and all leasehold interests in
- 14 minerals which are owned separately and apart from the surface
- 15 estate shall pay twenty-five percent (25%) of the property taxes.
- 16 Such tax shall become due and be payable in the same manner as
- 17 taxes on the surface estate.
- 18 (2) If the taxes provided for in subsection (1) of this
- 19 section are not paid when they become due, such mineral estate or
- 20 leasehold interest shall revert to the surface owner.
- 21 SECTION 2. Section 27-31-85, Mississippi Code of 1972, is
- 22 amended as follows:

- 23 27-31-85. From the taxes levied and collected under and by
- 24 virtue of Sections 27-31-77 through 27-31-83 inclusive, and
- 25 <u>Section 1 of this act,</u> the chancery clerk shall retain <u>ten percent</u>
- 26 (10%) as a fee for the collection thereof, and shall pay the
- 27 remainder thereof into the proper depository to the credit of the
- 28 county, one-half (1/2) to the common county fund and one-half
- 29 (1/2) to the county school fund. Such deposit shall be made on or
- 30 before the fifteenth day of the month next succeeding that in
- 31 which such collection may be made. * * *

- 32 **SECTION 3.** Sections 27-31-73 and 27-31-75, Mississippi Code
- 33 of 1972, which relate to the exemption of nonproducing mineral and
- 34 leasehold interests, are repealed.
- 35 **SECTION 4.** This act shall take effect and be in force
- 36 retroactively from and after January 1, 2007.
