HOUSE BILL NO. 1039

AN ACT TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE MOTOR VEHICLE LICENSE TAGS DISPLAYING THE PHRASE "IN GOD WE TRUST"; TO PROVIDE FOR THE COLLECTION OF AN ADDITIONAL FEE FOR THE ISSUANCE OF SUCH LICENSE TAGS; TO PROVIDE THAT A PORTION OF THE ADDITIONAL FEE SHALL BE DISBURSED IN EQUAL AMOUNTS TO THE MISSISSIPPI CHAPTER, ORGANIZATION OR DIVISION OF BOY SCOUTS OF AMERICA, GIRL SCOUTS OF the USA AND THE SALVATION ARMY; AND FOR RELATED PURPOSES.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9 SECTION 1. (1) Any owner of a motor vehicle, who is a 10 resident of this state, upon complying with the motor vehicle laws relating to registration and licensing of motor vehicles, and upon 11 payment of the road and bridge privilege taxes, ad valorem taxes 12 13 and registration fees as prescribed by law for private carriers of passengers, pickup trucks and other noncommercial motor vehicles, 14 and upon payment of an additional annual fee in the amount 15 provided in subsection (3) of this section, shall be entitled to a 16 17 distinctive license tag displaying the phrase "In God We Trust," for each motor vehicle registered in his name. The distinctive 18 license tags so issued shall be of such color and design as the 19 20 State Tax Commission may prescribe, and shall consist of such letters or numbers, or both, as may be necessary to distinguish 21 22 each license tag.

(2) Application for the distinctive license tags authorized
by this section shall be made to the county tax collector on forms
prescribed by the State Tax Commission. The application and the
additional fee imposed under subsection (3) of this section, less
Two Dollars (\$2.00) thereof to be retained by the tax collector,
shall be remitted to the State Tax Commission on a monthly basis
as prescribed by the commission. The portion of the additional

30 fee retained by the tax collector shall be deposited into the 31 county general fund.

32 (3) Beginning with any registration year commencing on or 33 after July 1, 2007, any person applying for a distinctive license 34 tag under this section shall pay an additional fee in the amount 35 of Thirty Dollars (\$30.00) for each distinctive license tag 36 applied for under this section, which shall be in addition to all other taxes and fees. The additional fee paid shall be for a 37 period of time to run concurrently with the vehicle's established 38 39 license tag year. The additional fee is due and payable at the time the original application is made for a distinctive license 40 41 tag under this section and thereafter annually at the time of renewal registration as long as the owner retains the distinctive 42 43 license tag. If the owner does not wish to retain the distinctive license tag, he must surrender it to the local county tax 44 45 collector.

46 (4) The State Tax Commission shall deposit all fees into the 47 State Treasury on the day collected. At the end of each month, 48 the State Tax Commission shall certify to the State Treasurer the 49 total fees collected under this section from the issuance of the 50 distinctive license tags issued under this section. The State 51 Treasurer shall distribute such collections as follows:

52 (a) Twenty-four Dollars (\$24.00) of each additional fee
53 collected on distinctive license tags issued pursuant to this
54 section shall be disbursed in equal amounts to the Mississippi
55 chapter, organization or division of Boy Scouts of America, Girl
56 Scouts of the USA and the Salvation Army.

57 (b) One Dollar (\$1.00) of each additional fee collected 58 on distinctive license tags issued pursuant to this section shall 59 be deposited into the Mississippi Burn Care Fund created pursuant 60 to Section 7-9-70.

61 (c) Two Dollars (\$2.00) of each additional fee

(d) One Dollar (\$1.00) of each additional fee collected
on distinctive license tags issued pursuant to this section shall
be deposited to the credit of the special fund created in Section
27-19-44.2.

(5) A regular license tag must be properly displayed as required by law until replaced by a distinctive license tag under this section. The regular license tag must be surrendered to the tax collector upon issuance of the distinctive license tag under this section. The tax collector shall issue month and year decals for each distinctive license tag issued under this section, which will expire the same month and year as the regular license tag.

77 In the case of loss or theft of a distinctive license (6) 78 tag issued under this section, the owner may make application and 79 affidavit for a replacement distinctive license tag as provided by Section 27-19-37. The fee for a replacement distinctive license 80 tag shall be Ten Dollars (\$10.00). The tax collector receiving 81 such application and affidavit shall be entitled to retain and 82 deposit into the county general fund five percent (5%) of the fee 83 84 for such replacement license tag and the remainder shall be 85 distributed proportionately in the same manner as funds from the sale of regular distinctive license tags issued under this 86 87 section.

88 **SECTION 2.** This act shall take effect and be in force from 89 and after July 1, 2007.
