HOUSE BILL NO. 1081

AN ACT TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE LICENSE TAGS 1 TO SUPPORTERS OF THE GFWC MISSISSIPPI FEDERATION OF WOMEN'S CLUB, 2 3 INCORPORATED; TO PRESCRIBE AN ADDITIONAL FEE FOR THE ISSUANCE OF 4 SUCH LICENSE TAGS; TO PROVIDE FOR THE DISTRIBUTION OF SUCH FEES; AND FOR RELATED PURPOSES. 5

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- SECTION 1. (1) Any owner of a motor vehicle who is a 7
- 8 resident of this state, upon payment of the road and bridge
- 9 privilege taxes, ad valorem taxes and registration fees as
- 10 prescribed by law for private carriers of passengers, pickup
- trucks and other noncommercial motor vehicles, and upon payment of 11
- 12 an additional fee in the amount provided in subsection (3) of this
- section, shall be issued a distinctive license tag for any motor 13
- 14 vehicle registered in his name identifying such person as a
- supporter of the GFWC Mississippi Federation of Women's Club, 15
- Incorporated. The distinctive license tags so issued shall be of 16
- such color and design as the State Tax Commission, with the advice 17
- of the Executive Board of the GFWC Mississippi Federation of 18
- 19 Women's Club, Incorporated, may prescribe and shall consist of
- such letters or numbers, or both, as may be necessary to 20
- 21 distinguish each license tag.
- (2) Application for the distinctive license tags authorized 2.2
- by this section shall be made to the county tax collector on forms 23
- prescribed by the State Tax Commission. The application and the 24
- additional fee imposed under subsection (3) of this section, less 25
- Two Dollars (\$2.00) thereof to be retained by the tax collector, 26
- shall be remitted to the State Tax Commission on a monthly basis 27
- 28 as prescribed by the commission. The portion of the additional

- 29 fee retained by the tax collector shall be deposited into the
- 30 county general fund.
- 31 (3) Beginning with any registration year commencing on or
- 32 after July 1, 2007, any person applying for a distinctive license
- 33 tag under this section shall pay an additional fee in the amount
- 34 of Thirty Dollars (\$30.00) for each distinctive license tag
- 35 applied for under this section, which shall be in addition to all
- 36 other taxes and fees. The additional fee paid shall be for a
- 37 period of time to run concurrently with the vehicle's established
- 38 license tag year. The additional fee is due and payable at the
- 39 time the original application is made for a distinctive license
- 40 tag under this section and thereafter annually at the time of
- 41 renewal registration as long as the owner retains the distinctive
- 42 license tag. If the owner does not wish to retain the distinctive
- 43 license tag, he must surrender it to the local county tax
- 44 collector.
- 45 (4) The State Tax Commission shall deposit all fees into the
- 46 State Treasury on the day collected. At the end of each month,
- 47 the State Tax Commission shall certify to the State Treasurer the
- 48 total fees collected under this section from the issuance of the
- 49 distinctive license tags issued under this section. The State
- 50 Treasurer shall distribute such collections as follows:
- 51 (a) Twenty-four Dollars (\$24.00) of each additional fee
- 52 collected on distinctive license tags issued pursuant to this
- 53 section shall be distributed to the GFWC Mississippi Federation of
- 54 Women's Club, Incorporated.
- 55 (b) One Dollar (\$1.00) of each additional fee collected
- on distinctive license tags issued pursuant to this section shall
- 57 be deposited into the Mississippi Burn Care Fund created pursuant
- 58 to Section 7-9-70.
- 59 (c) Two Dollars (\$2.00) of each additional fee
- 60 collected on distinctive license tags issued pursuant to this
- 61 section shall be deposited to the credit of the State Highway Fund

- 62 to be expended solely for the repair, maintenance, construction or
- 63 reconstruction of highways.
- (d) One Dollar (\$1.00) of each additional fee collected
- on distinctive license tags issued pursuant to this section shall
- 66 be deposited to the credit of the special fund created in Section
- 67 27-19-44.2.
- 68 (5) A regular license tag must be properly displayed as
- 69 required by law until replaced by a distinctive license tag under
- 70 this section. The regular license tag must be surrendered to the
- 71 tax collector upon issuance of the distinctive license tag under
- 72 this section. The tax collector shall issue up to two (2) license
- 73 decals for each distinctive license tag issued under this section,
- 74 which will expire the same month and year as the regular license
- 75 tag.
- 76 (6) In the case of loss or theft of a distinctive license
- 77 tag issued under this section, the owner may make application and
- 78 affidavit for a replacement distinctive license tag as provided by
- 79 Section 27-19-37. The fee for a replacement distinctive license
- 80 tag shall be Ten Dollars (\$10.00). The tax collector receiving
- 81 such application and affidavit shall be entitled to retain and
- 82 deposit into the county general fund five percent (5%) of the fee
- 83 for such replacement license tag and the remainder shall be
- 84 distributed in the same manner as funds from the sale of regular
- 85 distinctive license tags issued under this section.
- 86 **SECTION 2.** This act shall take effect and be in force from
- 87 and after July 1, 2007.
