## HOUSE BILL NO. 1145

- AN ACT TO REOUIRE THE BOARD OF TRUSTEES OF STATE INSTITUTIONS OF HIGHER LEARNING TO PREPARE AN ANNUAL REPORT ON THE ALLOCATION 3
- OF FUNDS TO THE VARIOUS STATE INSTITUTIONS PURSUANT TO THE AYERS
- SETTLEMENT AGREEMENT; TO PRESCRIBE THE MINIMUM CONTENTS OF THE REPORT; TO REQUIRE THE SUBMISSION OF THE REPORT TO THE 4

- CHAIRPERSONS OF CERTAIN LEGISLATIVE COMMITTEES; AND FOR RELATED 6 7 PURPOSES.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 8
- 9 SECTION 1. The Board of Trustees of State Institutions of
- 10 Higher Learning shall prepare a report on the allocation of funds
- to the various state institutions of higher learning pursuant to 11
- the settlement agreement in the case of Ayers v. Musgrove (Civil 12
- 13 Action No. 4:75CV9-B-D, in the United States District Court for
- the Northern District of Mississippi). The report must include, 14
- 15 but not necessarily be limited to, the following data:
- (a) For the then current fiscal year, the total funding 16
- appropriated to the Board of Trustees of State Institutions of 17
- Higher Learning for the benefit of the state institutions of 18
- 19 higher learning from the Ayers Settlement Fund created under
- 20 Section 37-101-27;
- (b) For the then current fiscal year, the amount allocated 21
- 22 to each individual state institution entitled to funding from the
- 23 Ayers Settlement Fund or any other state fund that may be created
- 24 in relation to the Ayers case;
- (c) A history of the annual Ayers funding allocated to each 25
- state institution that has received monies as a result of any 26
- 27 court order or agreement in the Ayers case, regardless of the name
- 28 of the fund or trust in the State Treasury from which the monies

- 29 originated, beginning with the year the institution first received
- 30 such funding;
- 31 (d) For each year that an amount is reported for a state
- 32 institution under paragraph (c) of this section, the amount
- 33 appropriated by the Legislature for the general support of that
- 34 institution; and
- 35 (e) For each state institution receiving monies as a direct
- 36 result of the Ayers case, a history of the state funding of the
- 37 institution for the ten (10) years immediately preceding the first
- 38 year in which that institution received any funding due to the
- 39 Ayers case.
- The report required under this section must be prepared and
- 41 submitted to the chairpersons of the Committees on Appropriations
- 42 and Universities and Colleges of the House of Representatives and
- 43 Senate before October 1 of each year.
- 44 **SECTION 2.** This act shall take effect and be in force from
- 45 and after July 1, 2007.
