9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
10	<b>SECTION 1.</b> (1) The State of Mississippi, acting through the
11	Department of Finance and Administration and on behalf of the

14	College, for the use and benefit of the Greenville Higher
15	Education Center, the following real property in Washington
