## HOUSE BILL NO. 1443

- AN ACT TO AMEND SECTION 55-23-5, MISSISSIPPI CODE OF 1972, TO EXPAND THE MEMBERSHIP OF THE MISSISSIPPI VETERANS MEMORIAL STADIUM
- 3 COMMISSION IN COMPLIANCE WITH THE ORDER OF THE UNITED STATES
- 4 DISTRICT COURT IN THE CASE OF AYERS V. FORDICE; AND FOR RELATED
- 5 PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 55-23-5, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 55-23-5. There is hereby created a commission to be known as
- 10 "The Mississippi Veterans Memorial Stadium Commission,"
- 11 hereinafter sometimes referred to as the commission, which shall
- 12 consist of six (6) members as follows:
- 13 (a) One (1) member shall be appointed by the Mayor of
- 14 the City of Jackson, Mississippi;
- (b) One (1) member shall be selected by the Board of
- 16 Trustees of State Institutions of Higher Learning from among the
- 17 membership of the board or shall be some other person designated
- 18 by the board;
- 19 (c) Two (2) members shall be appointed by the Governor
- 20 from the state at large outside of Hinds County, Mississippi, and
- 21 one (1) member shall be appointed by the Governor from Hinds
- 22 County, Mississippi. The appointee from Hinds County may be
- 23 selected from a list of three (3) persons submitted by the Hinds
- 24 County Board of Supervisors to the Governor;
- 25 (d) One (1) member shall be appointed in compliance
- 26 with the order of the United States District Court in the case of
- 27 Ayers v. Fordice, 879 F.Supp. 1419 (N.D. Miss. 1995), such

- 28 <u>appointee being</u> the President of Jackson State University, or his 29 designee.
- Terms of members shall begin on May 1, 1987, as follows: Of
- 31 the members appointed by the Governor, one (1) shall serve for a
- 32 term of one (1) year, one (1) for a term of two (2) years and one
- 33 (1) for a term of three (3) years; the member appointed by the
- 34 Mayor of the City of Jackson shall serve for a term of four (4)
- 35 years; and the member representing the Board of Trustees of State
- 36 Institutions of Higher Learning shall serve for a term of five (5)
- 37 years. Upon the expiration of the foregoing terms, members shall
- 38 serve for terms of five (5) years each. The appointing authority
- 39 shall fill any vacancy in the above terms by appointment of a
- 40 member for the unexpired term. Members shall be eligible for
- 41 reappointment. An appointed member serving on the commission on
- 42 April 30, 1987, shall be eligible for appointment to the
- 43 commission for a term beginning May 1, 1987, of either one (1),
- 44 two (2), three (3), four (4) or five (5) years, if such member is
- 45 otherwise qualified. One (1) member of the commission appointed
- 46 by the Governor shall be a person knowledgeable in marketing with
- 47 at least three (3) years actual experience therein and one (1)
- 48 member appointed by the Governor shall be a person of recognized
- 49 ability in a trade or business with at least five (5) years actual
- 50 experience therein. From and after May 1, 1987, the name of the
- 51 commission shall be the "Mississippi Veterans Memorial Stadium
- 52 Commission" and any references in Sections 55-23-3 through
- 53 55-23-11 to the Mississippi Memorial Stadium Commission or
- 54 commission shall mean the Mississippi Veterans Memorial Stadium
- 55 Commission unless the context clearly indicates a different
- 56 meaning. From and after May 1, 1987, the stadium shall be known
- 57 as the "Mississippi Veterans Memorial Stadium." The commission is
- 58 authorized to accept donations of money, property or services from
- 59 any public or private source to accomplish any physical

- 60 replacement or alterations of stadium property necessary to
- 61 accomplish the renaming of the stadium.
- The members of the commission shall serve without
- 63 compensation except that members shall be paid their actual and
- 64 necessary expenses in connection with the performance of their
- 65 duties as members of the commission, including mileage, as
- 66 authorized in Section 25-3-41, Mississippi Code of 1972, plus a
- 67 per diem as is authorized by Section 25-3-69, Mississippi Code of
- 68 1972, while engaged in the performance of their duties. The
- 69 expenses, mileage and per diem allowance shall be paid out of the
- 70 Mississippi Veterans Memorial Stadium Fund.
- 71 The commission shall elect from its membership a chairman who
- 72 shall preside over meetings and a vice chairman who shall preside
- 73 in the absence of the chairman. Three (3) members of the
- 74 commission shall constitute a quorum for the transaction of any
- 75 and all business of the commission.
- 76 The powers of the commission shall be exercised by a majority
- 77 of the members thereof, but it may delegate to one or more of its
- 78 members, or to its agents and employees, such powers and duties as
- 79 it may deem proper, and may adopt rules and regulations for the
- 80 conduct of its business and affairs. The commission shall
- 81 contract with a certified public accounting firm to conduct audits
- 82 of concession and novelty sales by vendors at the stadium. The
- 83 commission shall, as far as is practicable, provide that the cost
- 84 of such audits shall be paid by the vendor of such concessions or
- 85 novelties, or both.
- The commission shall appoint a director who shall have at
- 87 least a bachelor's degree from an accredited university or
- 88 college. The director shall have the responsibility for insuring
- 89 the marketing of tickets to events conducted in the stadium, in
- 90 addition to such other duties as the commission may designate.
- 91 Before entering upon the duties of his office, the director shall
- 92 give bond to the State of Mississippi in the sum of Fifty Thousand

- Dollars (\$50,000.00), and said bond shall be conditioned upon the 93 faithful discharge and performance of his official duty. 94 principal and surety on said bond shall be liable thereunder to 95 96 the state for double the amount of value of any money or property 97 which the state may lose, if any, by reason of any wrongful or 98 criminal act of said director. Said bond, when approved by the commission, shall be filed with the Secretary of State, and the 99 premium thereon shall be paid from the Mississippi Veterans 100
- Memorial Stadium Fund.

  SECTION 2. This act shall take effect and be in force from and after its passage.
