- AN ACT TO AMEND SECTION 75-75-105, MISSISSIPPI CODE OF 1972,
- 2 TO INCREASE FROM \$100.00 TO \$500.00 THE FEE IMPOSED BY THE
- 3 MISSISSIPPI ATHLETIC COMMISSION FOR THE ANNUAL LICENSE OR PERMIT
- 4 ISSUED BY THE COMMISSION TO A BOXER, WRESTLER, REFEREE, JUDGE,
- 5 MATCHMAKER, PROMOTER, MANAGER, TRAINER, SECOND, DIRECTOR OR
- 6 TIMEKEEPER, OF A BOXING, SPARRING OR WRESTLING MATCH UNDER THE
- 7 JURISDICTION OF THE COMMISSION; AND FOR RELATED PURPOSES.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 75-75-105, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 75-75-105. The commission shall have a seal and shall have
- 12 and is hereby vested with the sole direction, management, control
- 13 and jurisdiction over all boxing, sparring and wrestling matches
- 14 or exhibitions to be conducted, held or given within the State of
- 15 Mississippi.
- The commission has full power and authority and it shall be
- 17 its duty:
- 18 (a) To make and publish rules and regulations governing
- 19 the conduct of boxing, sparring and wrestling matches and
- 20 exhibitions, the time and place thereof, and the prices charged
- 21 for admission thereto;
- 22 (b) To accept application for and, in its discretion,
- 23 order a license or permit issued to promoters and participants of
- 24 these events, and to revoke the license or permit;
- 25 (c) To collect through the recorder of permits and
- licenses a fee of six percent (6%) of the gross receipts of every
- 27 boxing, sparring or wrestling match or exhibition, and a
- 28 reasonable fee not to exceed Five Hundred Dollars (\$500.00) for
- 29 each annual license or permit issued to a boxer, wrestler,

- 30 referee, judge, matchmaker, promoter, manager, trainer, second,
- 31 director or timekeeper; and
- 32 (d) To revoke any license or permit when, in its
- 33 judgment, the public welfare requires it.
- 34 The commission is prohibited from issuing regulations which
- 35 may be construed as granting a franchised or exclusive territory,
- 36 and from the issuing of any type of monopolistic license or
- 37 permit.
- 38 **SECTION 2.** This act shall take effect and be in force from
- 39 and after July 1, 2007.
