HOUSE BILL NO. 1674

1 AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE STATE TREASURY FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE 2 3 MISSISSIPPI PUBLIC SERVICE COMMISSION FOR THE FISCAL YEAR 2008. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. The following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the State 6 7 Treasury to the credit of the Public Service Commission Regulation 8 Fund, for the purpose of defraying the expenses of the Mississippi Public Service Commission for the fiscal year beginning 9 July 1, 2007, and ending June 30, 2008..... 10 11 5,489,758.00. SECTION 2. Of the funds appropriated under the provisions of 12 13 Section 1, not more than the amounts set forth below shall be expended for the respective major objects or purposes of 14 15 expenditure: MAJOR OBJECTS OF EXPENDITURE: 16 Personal Services: 17 18 Salaries, Wages and Fringe Benefits.. \$ 3,933,132.00 Travel and Subsistence..... 398,000.00 19 20 Contractual Services..... 813,306.00 21 Commodities..... 115,000.00 Capital Outlay: 22 0.00 Other Than Equipment..... 23 223,320.00 24 Equipment..... Funds are provided herein to adjust the Variable Compensation Plan to ensure that all full-time employees receive a pay increase equal to the realignment component of the Variable Compensation Plan or One Thousand Five Hundred Dollars (\$1,500.00), whichever is greater.

With the funds herein appropriated, it is the intention of 39 the Legislature that it shall be the agency's responsibility to 40 make certain that funds required to be appropriated for "Personal 41 Services" for Fiscal Year 2009 do not exceed Fiscal Year 2008 42 43 funds appropriated for that purpose, unless programs or positions 44 are added to the agency's Fiscal Year 2009 budget by the 45 Mississippi Legislature. Based on data provided by the Legislative Budget Office, the State Personnel Board shall 46 47 determine and publish the projected annual cost to fully fund all appropriated positions in compliance with the provisions of this 48 49 act. It shall be the responsibility of the agency head to insure 50 that no single personnel action increases this projected annual cost and/or the Fiscal Year 2008 appropriation for "Personal 51 52 Services" when annualized, with the exception of escalated funds. 53 If, at the time the agency takes any action to change "Personal 54 Services," the State Personnel Board determines that the agency has taken an action which would cause the agency to exceed this 55 projected annual cost or the Fiscal Year 2008 "Personal Services" 56 57 appropriated level, when annualized, then only those actions which reduce the projected annual cost and/or the appropriation 58 59 requirement will be processed by the State Personnel Board until 60 such time as the requirements of this provision are met.

Any transfers or escalations shall be made in accordance with 61 62 the terms, conditions and procedures established by law or 63 allowable under the terms set forth within this act. The State 64 Personnel Board shall not escalate positions without written 65 approval from the Department of Finance and Administration. The 66 Department of Finance and Administration shall not provide written 67 approval to escalate any funds for salaries and/or positions without proof of availability of new or additional funds above the 68 69 appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

**SECTION 3.** None of the funds herein appropriated by this act to the Public Service Commission shall be expended for any purpose that is not actually required or necessary for performing any of the powers or duties of the Mississippi Public Service Commission that are authorized by the Mississippi Constitution of 1890, state or federal law, or rules or regulations that implement state or federal law.

It is the intention of the Legislature that the SECTION 4. 81 Public Service Commission shall maintain complete accounting and 82 83 personnel records related to the expenditure of all funds appropriated under this act and that such records shall be in the 84 85 same format and level of detail as maintained for Fiscal Year 2007. It is further the intention of the Legislature that the 86 87 agency's budget request for Fiscal Year 2009 shall be submitted to the Joint Legislative Budget Committee in a format and level of 88 detail comparable to the format and level of detail provided 89 90 during the Fiscal Year 2008 budget request process.

91 SECTION 5. In addition to all other sums herein 92 appropriated, the following sum, or so much thereof as may be 93 necessary, is appropriated out of any money in the State Treasury H. B. No. 1674 \*HR05/A811\* 07/HR05/A811

94 to the credit of the Public Service Commission, for the purpose of 95 defraying the expenses of the Public Service Commission to 96 administer the Mississippi Telephone Solicitation Act, for the 97 fiscal year beginning July 1, 2007, and ending June 30, 2008..... 98 ......\$ 160,000.00.

99 SECTION 6. It is the intention of the Legislature that 100 whenever two (2) or more bids are received by this agency for the purchase of commodities or equipment, and whenever all things 101 stated in such received bids are equal with respect to price, 102 quality and service, the Mississippi Industries for the Blind 103 104 shall be given preference. A similar preference shall be given to the Mississippi Industries for the Blind whenever purchases are 105 106 made without competitive bids.

107 SECTION 7. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 108 credit of the proper fund or funds as set forth in this act, upon 109 110 warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the 111 112 proper person, officer or officers, in the manner provided by law. 113 SECTION 8. This act shall take effect and be in force from 114 and after July 1, 2007.
