No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

SECTION 3. It is the intention of the Legislature that the

Mississippi Real Estate Appraiser Licensing and Certification 76 77 Board shall maintain complete accounting and personnel records 78 related to the expenditure of all funds appropriated under this act and that such records shall be in the same format and level of 79 80 detail as maintained for Fiscal Year 2007. It is further the intention of the Legislature that the agency's budget request for 81 Fiscal Year 2009 shall be submitted to the Joint Legislative 82 83 Budget Committee in a format and level of detail comparable to the 84 format and level of detail provided during the Fiscal Year 2008 85 budget request process.

SECTION 4. It is the intention of the Legislature that 86 whenever two (2) or more bids are received by this agency for the 87 88 purchase of commodities or equipment, and whenever all things stated in such received bids are equal with respect to price, 89 quality and service, the Mississippi Industries for the Blind 90 shall be given preference. A similar preference shall be given to 91 the Mississippi Industries for the Blind whenever purchases are 92 93 made without competitive bids.
