THE EXPENSES OF THE MISSISSIPPI AUTHORITY FOR EDUCATIONAL

AN ACT MAKING AN APPROPRIATION FOR THE PURPOSE OF DEFRAYING

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

SECTION 1. The following sum, or so much thereof as may be

that no single personnel action increases this projected annual 61 62 cost and/or the Fiscal Year 2008 appropriation for "Personal 63 Services" when annualized, with the exception of escalated funds. If, at the time the agency takes any action to change "Personal 64 65 Services," the State Personnel Board determines that the agency has taken an action which would cause the agency to exceed this 66 projected annual cost or the Fiscal Year 2008 "Personal Services" 67 68 appropriated level, when annualized, then only those actions which 69 reduce the projected annual cost and/or the appropriation 70 requirement will be processed by the State Personnel Board until such time as the requirements of this provision are met. 71

72 Any transfers or escalations shall be made in accordance with 73 the terms, conditions and procedures established by law or 74 allowable under the terms set forth within this act. The State 75 Personnel Board shall not escalate positions without written 76 approval from the Department of Finance and Administration. The 77 Department of Finance and Administration shall not provide written 78 approval to escalate any funds for salaries and/or positions 79 without proof of availability of new or additional funds above the appropriated level. 80

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

Funds appropriated herein shall first be used for the continuation of a full and complete broadcast schedule of educational and instructional, professional growth, and public service programs, with the production of new films and programs to be secondary thereto.

90 SECTION 4. It is the intention of the Legislature that the 91 Mississippi Authority for Educational Television shall maintain 92 complete accounting and personnel records related to the 93 expenditure of all funds appropriated under this act and that such H. B. No. 1687 *HR05/A247* 07/HR05/A247 PAGE 3 (RM\ST) 94 records shall be in the same format and level of detail as 95 maintained for Fiscal Year 2007. It is further the intention of 96 the Legislature that the agency's budget request for Fiscal Year 97 2009 shall be submitted to the Joint Legislative Budget Committee 98 in a format and level of detail comparable to the format and level 99 of detail provided during the Fiscal Year 2008 budget request 100 process.

SECTION 5. Of the funds appropriated under the provisions of Section 2, One Million Six Hundred Forty-four Thousand Sixty-seven Dollars (\$1,644,067.00) shall be derived from the Education Enhancement Fund deposited pursuant to Sections 27-65-75 and 27-67-31, Mississippi Code of 1972.

106 SECTION 6. No part of the funds appropriated herein shall be 107 transferred to, expended by, or used, directly or indirectly, for the benefit of any public relations, publicity or publication 108 109 activities of any other state agency, department or officer, nor 110 shall any personnel paid or equipment purchased with funds 111 appropriated hereby be transferred or assigned to any other state agency, department or officer for public relations, publicity or 112 113 publication activities of such office.

SECTION 7. It is the intention of the Legislature that the Mississippi Authority for Educational Television shall have the authority to expend funds in the Capital Equipment Replacement Revolving Fund, in accordance with Section 37-63-17, Mississippi Code of 1972, for the purpose of purchasing technical equipment for operating the educational radio and television facilities.

SECTION 8. It is the intention of the Legislature that the Mississippi Authority for Educational Television shall have the authority to escalate its budget and expend funds from any source not to exceed Five Million Dollars (\$5,000,000.00) in accordance with rules and regulations of the Department of Finance and Administration in a manner consistent with the escalation of federal funds.

It is the intention of the Legislature that the 152 Executive Director of the Mississippi Authority for Educational 153 Television may increase major objects of expenditure in total 154 amounts not to exceed twenty-five percent (25%) of the appropriated amount of each major object of expenditure, provided 155 156 that other major objects of expenditure are decreased by a corresponding dollar amount and provided the Executive Director of 157 158 the Mississippi Department of Finance and Administration also 159 approves with written authorization. SECTION 11. It is the intention of the Legislature that 162 163 whenever two (2) or more bids are received by this agency for the 164 purchase of commodities or equipment, and whenever all things 165 stated in such received bids are equal with respect to price, 166 quality and service, the Mississippi Industries for the Blind shall be given preference. A similar preference shall be given to 167 the Mississippi Industries for the Blind whenever purchases are 168 169 made without competitive bids.

170 **SECTION 12.** It is the intention of the Legislature that an 171 amount equal to One Dollar and Fifty Cents (\$1.50) per square foot 172 shall be paid to the Executive Office of the State Board of 173 Institutions of Higher Learning to defray utility costs.

SECTION 13. The money herein appropriated shall be paid by 174 175 the State Treasurer out of any money in the State Treasury to the 176 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 177 178 Officer shall issue his warrants upon requisitions signed by the 179 proper person, officer or officers, in the manner provided by law. SECTION 14. This act shall take effect and be in force from 180 and after July 1, 2007. 181
