HOUSE BILL NO. 1695

1 AN ACT MAKING AN APPROPRIATION TO THE GOVERNOR'S
2 OFFICE-DIVISION OF MEDICAID FOR THE PURPOSE OF PROVIDING MEDICAL
3 ASSISTANCE UNDER THE MISSISSIPPI MEDICAID LAW AND DEFRAYING THE
4 EXPENSES OF THE ADMINISTRATION OF SUCH LAW FOR THE FISCAL YEAR
5 2008.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 SECTION 1. The following sum, or so much thereof as may be
8 necessary, is hereby appropriated out of any money in the State
9 General Fund not otherwise appropriated, to the Governor's Office
10 - Division of Medicaid for the purpose of providing medical
11 assistance under the Mississippi Medicaid Law and defraying the
12 expenses of the administration of such law, as provided in Section
13 43-13-101 et seq., Mississippi Code of 1972, for the fiscal year
14 beginning July 1, 2007, and ending June 30, 2008.....
15 \$ 385,585,091.00.

16 SECTION 2. The following sum, or so much thereof as may be
17 necessary, is hereby appropriated out of any money in the State
18 Treasury to the credit of the Medical Care Fund created by Section
19 43-13-143, Mississippi Code of 1972, for the purpose of providing
20 medical assistance under the Mississippi Medicaid Law for the
21 fiscal year beginning July 1, 2007, and ending June 30, 2008.....
22 \$ 290,875,942.00.

23 SECTION 3. The following sum, or so much thereof as may be
24 necessary, is hereby appropriated out of any money in any special
25 fund in the State Treasury to the credit of the Governor's Office
26 - Division of Medicaid which is comprised of special source funds
27 collected by or otherwise available to the commission, for the
28 purpose of providing medical assistance under the Mississippi



29 Medicaid Law and defraying the expenses of the administration of
30 such law, for the fiscal year beginning July 1, 2007, and ending
31 June 30, 2008..... \$ 3,377,652,498.00.

32 Prior period recovery of funds may be maintained and expended
33 by the division when the recovery is received or finalized.

34 **SECTION 4.** The following sum, or so much thereof as may be
35 necessary, is hereby appropriated out of any money in the State
36 Treasury to the credit of the Health Care Expendable Fund, for the
37 purpose of defraying the expenses of the Governor's Office -
38 Division of Medicaid for the fiscal year beginning July 1, 2007,
39 and ending June 30, 2008..... \$ 78,293,220.00.

40 The above funds shall be allocated as follows:

49 It is the intention of the Legislature that funds may be
50 shifted among the above allocated line items where needed in the
51 discretion of the Executive Director of the Division of Medicaid.

52 **SECTION 5.** Of the funds appropriated under the provisions of
53 Sections 1, 2, 3 and 4, not more than the amounts set forth below
54 shall be expended for the respective major objects or purposes of
55 expenditure:

78 Funds are provided herein to adjust the Variable Compensation
79 Plan to ensure that all full-time employees receive a pay increase
80 equal to the realignment component of the Variable Compensation
81 Plan or One Thousand Five Hundred Dollars (\$1,500.00), whichever
82 is greater.

83 With the funds herein appropriated, it is the intention of
84 the Legislature that it shall be the agency's responsibility to
85 make certain that funds required to be appropriated for "Personal
86 Services" for Fiscal Year 2009 do not exceed Fiscal Year 2008
87 funds appropriated for that purpose, unless programs or positions
88 are added to the agency's Fiscal Year 2009 budget by the
89 Mississippi Legislature. Based on data provided by the
90 Legislative Budget Office, the State Personnel Board shall
91 determine and publish the projected annual cost to fully fund all
92 appropriated positions in compliance with the provisions of this
93 act. It shall be the responsibility of the agency head to insure
94 that no single personnel action increases this projected annual



95 cost and/or the Fiscal Year 2008 appropriation for "Personal
96 Services" when annualized, with the exception of escalated funds.
97 If, at the time the agency takes any action to change "Personal
98 Services," the State Personnel Board determines that the agency
99 has taken an action which would cause the agency to exceed this
100 projected annual cost or the Fiscal Year 2008 "Personal Services"
101 appropriated level, when annualized, then only those actions which
102 reduce the projected annual cost and/or the appropriation
103 requirement will be processed by the State Personnel Board until
104 such time as the requirements of this provision are met.

105 Any transfers or escalations shall be made in accordance with
106 the terms, conditions and procedures established by law or
107 allowable under the terms set forth within this act. The State
108 Personnel Board shall not escalate positions without written
109 approval from the Department of Finance and Administration. The
110 Department of Finance and Administration shall not provide written
111 approval to escalate any funds for salaries and/or positions
112 without proof of availability of new or additional funds above the
113 appropriated level.

114 No general funds authorized to be expended herein shall be
115 used to replace federal funds and/or other special funds which are
116 being used for salaries authorized under the provisions of this
117 act and which are withdrawn and no longer available.

118 **SECTION 6.** It is the intention of the Legislature that the
119 Governor's Office - Division of Medicaid shall maintain complete
120 accounting and personnel records related to the expenditure of all
121 funds appropriated under this act and that such records shall be
122 in the same format and level of detail as maintained for Fiscal
123 Year 2007. It is further the intention of the Legislature that
124 the agency's budget request for Fiscal Year 2009 shall be
125 submitted to the Joint Legislative Budget Committee in a format
126 and level of detail comparable to the format and level of detail
127 provided during the Fiscal Year 2008 budget request process.



128 **SECTION 7.** In compliance with the "Mississippi Performance
129 Budget and Strategic Planning Act of 1994," it is the intent of
130 the Legislature that the funds provided herein shall be utilized
131 in the most efficient and effective manner possible to achieve the
132 intended mission of this agency. Based on the funding authorized,
133 this agency shall make every effort to attain the targeted
134 performance measures provided below:

141 A reporting of the degree to which the performance targets
142 set above have been or are being achieved shall be provided in the
143 agency's budget request submitted to the Joint Legislative Budget
144 Committee for Fiscal Year 2009.

145 **SECTION 8.** It is the intention of the Legislature that
146 whenever two (2) or more bids are received by this agency for the
147 purchase of commodities or equipment, and whenever all things
148 stated in such received bids are equal with respect to price,
149 quality and service, the Mississippi Industries for the Blind
150 shall be given preference. A similar preference shall be given to
151 the Mississippi Industries for the Blind whenever purchases are
152 made without competitive bids.

153 **SECTION 9.** Of the funds appropriated in Sections 1, 2, 3 and
154 4, an additional amount not less than Two Hundred Fifty Thousand
155 Dollars (\$250,000.00) shall be expended in the Home and Community
156 Based Waiver Program over and above the amount expended in Fiscal
157 Year 2007.

158 **SECTION 10.** In the event that funding is available from
159 sources set forth in the above sections, and with the approval of
160 all applicable state and federal agencies, the division may



161 establish a program to provide for physician retention
162 supplemental Medicaid payments for physicians in hospitals located
163 in counties which have been declared a disaster area as a result
164 of Hurricane Katrina. The division may make additional Medicaid
165 reimbursement to physicians who meet all requirements of this
166 physician retention program, as established by the division.

167 **SECTION 11.** Of the funds appropriated under the provisions
168 of Section 2, Ninety Million Dollars (\$90,000,000.00) shall be
169 derived from the Working Cash-Stabilization Reserve Fund for the
170 purpose of providing medical assistance under the Mississippi
171 Medicaid law.

172 **SECTION 12.** The money herein appropriated shall be paid by
173 the State Treasurer out of any money in the State Treasury to the
174 credit of the proper fund or funds as set forth in this act, upon
175 warrants issued by the State Fiscal Officer; and the State Fiscal
176 Officer shall issue his warrants upon requisitions signed by the
177 proper person, officer or officers, in the manner provided by law.

178 **SECTION 13.** This act shall take effect and be in force from
179 and after July 1, 2007.
