HOUSE CONCURRENT RESOLUTION NO. 61

1 A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING THE
2 WAYNE COUNTY HIGH SCHOOL WAR EAGLES FOOTBALL TEAM FOR ITS
3 OUTSTANDING 2006 SEASON AND FOR WINNING THE CLASS 4A STATE
4 CHAMPIONSHIP.

5 WHEREAS, the Wayne County High School War Eagles Football
6 Team finished the 2006 season with an exceptional undefeated
7 record of 15-0; and

8 WHEREAS, throughout the season the War Eagles participated in
9 playoffs, which included victories as the 4A South State Champions
10 and 4A State Champions; and

11 WHEREAS, prior to claiming this year's state title, the Wayne
12 County High School War Eagles won back-to-back state
13 championships, winning the 5A State Championship in 2002 and the
14 4A State Championship in 2003; and

15 WHEREAS, the War Eagles were superbly coached and inspired by

21 himself and to Wayne County High School by being selected as Coach
22 of the Year by the Mississippi Association of Coaches; and

23 WHEREAS, several of the War Eagles have been recognized for
24 their hard work, dedication and superior play this season,
25 including the naming of Kenneth Whigham, Marquese Ray and Drexler
26 Johnson as All-State Team Members; and

27 WHEREAS, the Wayne County High School War Eagles, have
28 developed a winning and cooperative spirit and a superb degree of

29 sportsmanship and their activities and attitude reflect great
30 credit upon the individual players and their coaches and bring
31 great honor to Wayne County High School; and

32 WHEREAS, it is the policy of this Legislature to recognize
33 and commend excellence, especially when demonstrated by the young
34 people of our state, who are its future:
