9	fatalities and gang shootings touch countless lives and continue
10	to have an impact long after the initial event; and
11	WHEREAS, grieving is a natural and normal response to death
12	and other losses and is a healthy way for people to process their
13	grief; and
14	WHEREAS, cultural traditions and religious institutions have
15	historically recognized the need for community mourning rituals
16	and individual grief expressions; and
17	WHEREAS, all persons are urged to be sensitive and supportive
18	of their families, neighbors, friends and colleagues who are
19	adjusting to a significant loss in their lives; and
20	WHEREAS, a week set aside for grief awareness will enhance
21	solidarity with our human mortality and our common need for
22	mourning and healing and will promote spiritual, mental, physical
23	and emotional health; and
