HOUSE CONCURRENT RESOLUTION NO. 71

1 A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING MRS.

15 instructor, has been employed at the Mississippi Gulf Coast

18 WHEREAS, Mrs. Lisa Courtney received her associate of arts
19 degree from Mississippi Gulf Coast Community College, her bachelor
20 of science degree from the University of Southern Mississippi and
21 her master of education from the University of Southern
22 Mississippi; and

23 WHEREAS, Mrs. Lisa Courtney serves as the Chairperson of the
24 Perkinston Campus Career and Technical Education department;
25 serves as adviser to Perkinston Campus Phi Beta Lambda; is a
26 member of the Mississippi Gulf Coast Community College

27 Instructional Affairs Council, Planning Council and Student
28 Advisement System Development Team; and

29 WHEREAS, Mrs. Lisa Courtney is a graduate of the Mississippi
30 Gulf Coast Community College Leadership Program and a lifetime
31 member of the Mississippi Gulf Coast Community College Alumni
32 Association and Foundation; and

33 WHEREAS, Mrs. Lisa Courtney has received many honors
34 including being named the 2004 HEADWAE honoree, the 2003
35 Mississippi Business Education Association Outstanding Educator of
36 the Year and the 2001 Mississippi Phi Beta Lambda Local Chapter
37 Adviser of the Year; and

39 participating as a member in various organizations such as serving
40 as the secretary of the Stone County Chamber Board, a member and
41 officer of the Mississippi Business Education Association, a
42 member and officer of the Perkinston Campus Faculty Association, a
